Mayor Hyslop, Alderman Kressin, Alderperson Schaffer, Alderman Burkett, and Alderperson Marquardt were all sworn in by Clerk Bolte, beginning their new, two-year terms of office ending 4/2025.

- 4) <u>Designate official radio station: WERL/WRJO:</u> Motion by Kressin, 2nd by Schaffer to designate WERL/WRJO as the official radio station for the City. Carried, all

- Appointment of Business Improvement District Board Chair: Robin Ginner Burkett suggested adjusting the term of this position to be until sitting mayor is removed. Motion by Marquardt, 2nd by Schaffer to appoint Robin Ginner as Mayor appointed Chair of the Business Improvement District, with the term "until sitting mayor is removed." Carried, all
- 20) Appointment of Council representative to Eagle River Revitalization Board of Directors: Kressin Motion by Schaffer, 2nd by Marquardt to appoint Kressin as Council representative the Eagle River Revitalization Board of Directors. Carried, all
- 21) <u>Appointment of Council representative Joint Review Board: Kressin</u> *Motion by Burkett, 2nd by Marquardt to appoint Kressin as Council representative to the Joint Review Board. Carried, all*
- 22) <u>Appointment of Council representative to Unified Lower Eagle River Chain of Lakes Commission: Kressin</u> Motion by Burkett, 2nd by Schaffer to appoint Kressin as Council representative of the Unified Lower Eagle River Chain of Lakes Commission. Carried, all
- 23) Appoint City of Eagle River representative to the Walter E. Olson Library Board: Kathy Patten Motion by Schaffer, 2nd by Kressin to appoint Kathy Patten as Eagle River representative to the Walter E. Olson Library Board. Carried, all
- 24) <u>Approve members of the governing body to appear via phone or digital communication platforms:</u> *Motion by Burkett, 2nd by Kressin to approving members of the governing body to appear via phone or digital communication platforms. Carried, all*
- 25) Approve other board and committee members to appear via phone or digital communication platforms upon approval of the Chairperson. Motion by Burkett, 2nd by Kressin to approve other board and committee members to appear via phone or digital communication platforms. Carried, all
- Resolution #1007 to increase the salaries for City Council members and Mayor following 2025 Spring Election: Mayor Hyslop suggested an additional increase in pay from presented resolution for the Council President as the President has extra duties beyond the other Council members. After much discussion, Motion was made by Kressin, 2nd by Marquardt to approve Resolution #1007, increasing the Mayor salary to \$23,400 per year, increasing Council members salary to \$6,900 per year AND adding to the presented resolution: The Council President shall have his/her salary increased to the amount of \$8,100 per year. All increases will go into effect following the April 2025 election. Carried on a roll call vote, all.
- 27) <u>Ordinances and Resolutions must be introduced by one member of governing body:</u> Motion by Burkett, 2nd by Kressin that all ordinances and resolutions must be introduced by one member of the governing body. Carried, all
- Anonymous correspondence will not be included in Council meeting packets: Motion by Burkett, 2nd by Marquardt that all complaints, correspondence, and comments do not exist if they are not signed. Carried, all
- Approve six-month extension of Interim Financing for Wastewater Treatment Plant project with Great North Bank, \$2.8 million at the rate of 4.7% through October 13, 2023. Ginner reported the need to extend the interim financing to get everything finished at the WWTP. The interest rate has gone from 2.8% when the original note was taken out to 4.7%. Motion by Burkett, 2nd by Kressin to approve a six-month extension of the interim financing for the Wastewater Treatment Plant project with Great North Bank, \$2.8 million with an interest rate of 4.7% through October 13, 2023. Carried on a roll call vote, all

Due to the lack of availability of the full Council to stay, the planned closed session for Employment Reviews of the City Treasurer, City Clerk and City Administrator was postponed by Mayor Hyslop and Council until the regular May 9th City Council meeting.

Motion by Schaffer, 2nd by Burkett to adjourn the meeting at 5:17PM. Carried all.
