Motion by Burkett, 2<sup>nd</sup> by Kressin to approve Resolution 1031 increasing the fee for a 2-year operators license to \$30 effective 4/1/2024. Carried on a roll call vote, all.

- G) <u>MSA Monthly Update</u>: Phil Kriesel provided a written report, including updates to the E Spruce Street and N Third Street Utility Improvement Project. Robin Ginner reported that the project included some sidewalk areas that are located on private property on Third Street. Temporary construction easements have been drafted, with drafts approved by City Attorney. *Motion by Burkett, 2<sup>nd</sup> by Kressin to move ahead with securing temporary easements from Peter Anderson and Christ Lutheran Church for the Spruce and Third Utility Improvement project. Carried, all.*

Krisel of MSA presented an Agreement for 2024 Non-TID professional services for an estimated fee of \$5,000 for a term of 2/13/24 - 12/31/24. Motion by Burkett,  $2^{nd}$  by Kressin to approve MSA Non TID professional services agreement for 2024 with a limit up to \$5,000. Carried on a roll call vote, all.

H) Ordinance #587 – Amendment to Municipal Code, Chapter 86 Traffic and Vehicles, Addition of Section 86-8 Miscellaneous Traffic Regulations – Disorderly Conduct with a Motor Vehicle: Police Chief Dobbs presented the Ordinance citing it is a tool to close out cases. Dobbs confirmed that Vilas County Judges, Judge Milanowski and Judge Overbey have seen the draft ordinance and both are OK with it. Motion by Burkett, 2<sup>nd</sup> by Kressin to approve Ordinance 587 – Disorderly Conduct with a Motor Vehicle, effective February 22, 2024, after required publication. Carried on a roll call vote, all.

I) Light & Water: Note Anticipation Note (NAN) refunding options presented by Brad Viegut, Baird: Brad Viegut, Managing Director at BAIRD Financial presented via zoom, the refunding options for the 2019 Note Anticipation Note. Viegut explained this is long term financing to replace the short-term NAN that was taken out for funding electric projects. Viegut reported the amount to be financed was \$1,155,000 in General Obligation Refunding Bonds with an anticipated interest rate of 4.39% with a final payment in May 2043. Burkett questioned if local banks had been contacted with John Laszczkowski of Eagle River Light Water giving his reasons why it wasn't a viable option. Burkett also questioned prepayment options with Viegut going into detail on the options, concluding that the presented GO refunding bond was the best plan with first prepay option in 2032.

Resolution 1032: Resolution Authorizing the Issuance and Establishing Parameters for the Sale of Not to Exceed \$1,200,000 General Obligation Refunding Bonds: Motion by Burkett, 2<sup>nd</sup> by Kressin to approve Resolution 1032: Resolution Authorizing the Issuance and Establishing Parameters for the Sale of Not to Exceed \$1,200,000 General Obligation Refunding Bonds. Carried on a roll call vote, Ayes: Burkett, Kressin, Marquardt, Schaffer Nays: None

- J) <u>Silver Lake Eurasian Milfoil Treatment Update:</u> Ginner provided supporting documents, reporting that the grant application for the treatment of Eurasian Milfoil on Silver Lake submitted on our behalf by Onterra was not successful citing there were too many applicants to fund them all. Discussion on the need and the importance of Silver Lake for tourism. The treatment costs are split as follows: 40% City of Eagle River, 50% Silver Lake Association, and 10% Town of Lincoln. Ginner requested Council approval to proceed with RFP (request for proposal) to treat Eurasian Milfoil with herbicide. *Motion by Kressin, 2<sup>nd</sup> by Marquardt to proceed with RFP for Silver Lake Milfoil treatment. Carried, all.*
- K) <u>Eagle River Airport: Update on Act 12 personal property repeal Hangars moving to tax roll as BFI (Buildings, Fixtures, Improvements):</u> Bolte gave an update on the need to have metes and bounds legal descriptions for each of the hangars, previously taxes as personal property, in order to complete the required BFI document to convey Buildings, Fixtures, and Improvements on leased land. The current descriptions attached to each hangar are by physical address and will not be accepted for parcel generation. Greg Maines of Maines and Associates Land Surveyors submitted a proposal to prepare an overall map and individual metes and bounds legal descriptions for the 70+/- airplane hangars at the Eagle River Airport totaling \$8,750.00. Motion by Burkett, 2<sup>nd</sup> by Kressin to approve the survey contract with Maines & Associates Land Surveyors, up to \$8,750.00 for metes and bounds legal descriptions for BFI form reporting. Carried on a roll call vote, all.
- L) <u>Information Item: Mayoral Proclamation of Veterans and Families' Expressions Weekend, March 23-24, 2024</u>: Council President Schaffer read the Proclamation into record. Full proclamation available at Eagle River City Hall, Clerks office.
- M) <u>Approve updates to Employee Manual related to Organizational Chart, HRA benefits, Timekeeping and Holiday Hours for Clerk/Treasurer office.</u> Ginner provided copies of the changes to the Employee Policy Handbook for review and summarized proposed updates to organizational chart, the change to time-keeping now in 15-minute intervals, HRA fee increase to employees and inclusion of right to waive participation in the HRA, and removal of Clerk and Treasurer requirement to be open on December 31

which also removed the floating holiday for Clerk and Treasurer. *Motion by Burkett, 2<sup>nd</sup> by Kressin to approve the changes to the Employee Policy Handbook as presented. Carried, all.* 

- N) <u>Approve payment of bills for the city and the golf course</u>: *Motion by Kressin, 2<sup>nd</sup> by Burkett to approve* payment of the bills for the city and the golf course as recommended by the Finance Committee. Carried on a roll call vote, Ayes: Kressin, Burkett, Schaffer, Nayes: None, Marquardt abstaining.
- O) <u>Police chief report on departmental activities</u>: Chief Dobbs supplied a written update of current activity and events for review. Dobbs gave update on a grant the department is working on for an officers retreat, a wellness type program that they are trying to bring to the Northwoods for all first responders.
- P) <u>Administrators report on activities in all departments & general monthly duties:</u> Ginner presented a written update of departmental happenings for review.
- Q) <u>Treasurer's monthly update:</u> Hoffmann gave a verbal report of her happenings in the Treasurers office, including trainings Hoffmann has attended, posting of the due to/froms she is working on between the City and the Golf Course, reporting the golf course loan repayment will not happen until course opens back up, and report that CLA requested she dig into 2022 due froms from the golf course.
- R) Clerk's monthly update: Bolte provided a written report/Clerk position procedural update for review.
- S) Golf Course Updates from Golf Pro and Greens Superintendent:

Greens Equipment Purchase Request: Two carts and a Buffalo Blower for \$39,903.56: Anderson reported the need for two (2) additional utility carts and a replacement blower. Anderson stated that one of the existing carts is on its last leg and there are not enough carts for employees. The course had two blowers but one is no longer functional and not worth repairing. A bid was received from Revels Turf & Tractor for a 2024 John Deere Gator TX Turf cart for \$14,352.28 each and a Buffalo Turbine KB6 blower for \$11,199.00. A bid was received from Reinders for a TORO Workman MDX with Electric Lift Kit at \$14,161 each and a Pro Force Blower for \$10,291. Burkett asked if the items were budgeted for in the 2024 budget with Ginner stating no, and stated the purchases would be funded by cash pulled from the golf course account in May, after the course opens. Burkett said he wants future purchases to come before the Council prior to budget being set. Motion by Burkett, 2<sup>nd</sup> by Kressin to approve the purchase of two utility carts and a blower using golf course funds, not to exceed \$39,903. Carried on a roll call vote, all.

Sable reported the welcome letter and rate cards are ready to go for season pass holder mailing, with rates remaining unchanged. Sable confirmed with Ginner that the code of conduct will need to be signed yearly by all season pass holders.

<u>Approval of RFP for Media and Marketing Services</u>: Ginner stated the city would like to look at other marketing companies for the golf course. Ginner presented a request for proposal for Municipal Marketing and Branding Initiative for the Eagle River Municipal Golf Course for approval. *Motion by Kressin, 2<sup>nd</sup> by Burkett to proceed with RFP for Media and Marketing Services as presented. Carried, all.* 

<u>2024 Golf Course Restaurant Lease Proposal Review:</u> Ginner presented that one proposal was received for the golf course restaurant lease. The received proposal was prepared by Blaze Champeny. Blaze presented that he is the owner at Wild Turkey restaurant in Conover, stating that he would strive to meet restaurant expectations to the level of the golf course. Discussion on labor force and set hours for opening. Discussion on winter hours and the clubhouse building not being insulated for winter month operation.

Motion by Burkett, 2<sup>nd</sup> by Kressin at 7:35PM to adjourn to closed session according to WI State Statute 19.85 (1) (e) Deliberating or negotiating the purchasing of public properties, the investing of public funds, or conducting other specified public business, whenever competitive or bargaining reasons: Deliberation of 2024 Golf Course Restaurant Lease Proposal. Motion carried, all.

Motion by Burkett, 2<sup>nd</sup> by Kressin at 8:25PM to reconvene in Open Session according to Wisconsin State Statute 19.85(2) with possible action on closed session agenda items. Carried, all.

# Yellow Birch T-Dock Landing Shoreline Project - Spring/Summer 2024

# Proposal:

Enhance the shoreline buffer of the Yellow Birch Lake T-docks area on the City of Eagle River owned property.

In the early 2000s, the Vilas County Land and Water Conservation Department, along with volunteers from the Eagle River Chain of Lakes Association, created a demonstration shoreline buffer to show riparian owners how they can add more native plant species to their shoreline buffers and do so in an aesthetically pleasing way. Improving the diversity of plants will enhance pollinator and other wildlife habitat and reduce soil erosion.

The city has continued to honor the buffer area by not mowing close to the water's edge, but due to the high number of deer and the limited plant choice 20 years ago, the flowering plants have disappeared. Currently there is a nice community of native sedges and grasses, but adding in native flowering plants that are not desired by deer will be more attractive and attract more attention from visitors. Enhancing the shrub community will also do the same. Species available to accomplish this have become more available in the nursery trade, especially species that are not as desired by deer.

# **Project Objectives:**

- Erosion Control increase the density and diversity of root mass.
- Increase Habitat enhance the vegetative diversity for pollinators and birds.
- Geese Deterrent geese don't care to walk through a thick buffer of shrubs and perennials, they prefer short lawns where they can watch for predators.


- Demonstration Area As a popular public access area the T-Docks can provide an educational opportunity to showcase healthy shoreline buffers.
- Enhance ERCLA's commitment for continued grants.

# Costs/Labor

- ERCLA has committed \$1200.00 for plants and shrubs.
- Three signs require upgrading.
  - 1. VCL&WCD provides content.
  - 2. City of Eagle River provides newly printed signs. Minimal costs.
  - 3. ERCLA repaints the framings.
- Labor ERCLA volunteers.

# **Actions/Timing**

- Remove thistle from the shoreline. Late March/Early April
- Plant flower plants in amongst the existing grasses. April/May
- Spread seed in the grassy areas. (Seeds provided by VCL&WCD) April/May
- Add substantial short shrubs (2-3ft) along some areas for increased stabilization April/May.
- City of ER continues to not mow the immediate 5 ft of buffer area along 565 ft of shoreline.
- Maintain area with weed control, watering as needed, and deer spraying for two growing seasons. (ERCLA volunteers)

The City references some of this data as basemaps in their apps. MSA will be updating any of the links from Vilas County basemaps that are used in the City's apps.

# WDNR INTENT TO APPLY - CLEAN WATER FUND AND SAFE DRINKING WATER LOAN PROGRAMS

In October MSA will again submit ITA's for projects the city will consider over the next year. There is no fee for this service. It is important to think about what possible projects could come up in the next year to apply for. This should be looked at like a wish list. Funding changes will happen over the next year, and this is the required first step in using DNR loan and grant programs.

# Amendment to Municipal Code - Chapter 10 Animals Section 10-4 Control of Dogs and Cats

Whereas; the Planning Commission along with the City Attorney has reviewed the Municipal Code, Chapter 10 Animals, Section 10-4 – Control of Dogs and Cats;

Whereas; The Common Council of the City of Eagle River desires to amend the Municipal Code; Chapter 10 -Animals, Section 10-4 Control of Dogs and Cats;

Therefore; The Common Council of the City of Eagle River does hereby ordain to amend Chapter 10 - Animals, Section 10-4 Control of Dogs and Cats of the Municipal Code of Ordinances of the City of Eagle River as follows:

# Delete Section 10-4 (a) (b) (d) and (e) Control of dogs and cats:

- (a) At large. No person shall permit any dog or cat to be at large in the city at any time. A dog or cat is at large when the animal is on any public street, alley, park or other public grounds, or when otherwise off the premises of the owner or person who has custody of such dog or cat, and not constrained by a leash or otherwise under the immediate control of the owner or the person who has custody of such dog or cat.
- (b) Prohibition against animals in public grounds and facilities. No owner or person having control of any dog, cat or other animal shall permit such dog, cat or other animal to enter into or be upon any public park, school grounds, public building or other public grounds, even if such animal is leashed and within the immediate control of the owner or custodian of the animal.
- (d) Exhibition and amusement. Notwithstanding any restrictions or prohibitions contained in this section, animals of any kind and in any number may be kept for exhibition or amusement purposes, temporarily, by a carnival or circus offering exhibitions within the city limits; however, all animal defecation shall be cleaned up and removed by the owners and/or operators of such circus or carnival.
- (e) Exceptions. The provisions of this section shall not be applicable to any guide dog owned or controlled by any visually handicapped person or law enforcement dogs. Sec. 10-4. - Control of dogs and cats.

## Add Section 10-4 (a) (b) (d) and (e) Control of dogs and cats;

(a)At large. No person shall permit any dog or cat to be at large in the city at any time. A dog or cat is at large when the animal is on any public street, alley, park or other public grounds, or when otherwise off the premises occupied by the owner or person who has custody of such dog or cat and is not constrained by a physical leash and within immediate control and vicinity of the owner or the person who has custody of such dog or cat.

- (b)Prohibition against animals in public grounds and facilities. No owner or person having control of any dog, cat or other animal shall permit such dog, cat or other animal to enter into or be upon any public park, school grounds, public building or other public grounds unless such animal is physically leashed and within the immediate control and vicinity of the owner or custodian of the animal, and where the public grounds and facilities are not otherwise signed prohibiting animals.
- (d)Exhibition and amusement. Notwithstanding any restrictions or prohibitions contained in this section, individuals or companies possessing animals of any kind and any number kept for exhibition or amusement purposes, temporarily, by a carnival or circus offering exhibitions within the city limits must obtain a permit through the Cityof Eagle River to exhibit said animals. All animal defectation shall be cleaned up and removed by the owners and/or operators of such circus or carnival.
- (e)Exceptions. The provisions of this section shall not be applicable to any service animal owned or controlled by any disabled person or law enforcement. Service animals are not exempt from being physically leashed and within immediate control and vicinity unless the work of the animal requires that they be un-leashed; however, the animal must always be within the immediate control of the owner or person who has custody of the animal.

### Section 10-4 (c) remains unchanged.



PROJECT EQUIPMENT: Schmidt's Aquatic vessel is a 24' Sea Ark, which can carry 2500Lbs of herbicide. All the equipment is calibrated and injected sub surface, utilizing 6 bow mounted drop hoses, which vary in depth depending on the average depth of the weeds. This in turn increases herbicide concentration and exposure time. Our GPS system is a Case FM750 which has a +/- reading of 0.75 feet of accuracy for correct chemical placement. We also use a Garmin 65 GPS as an additional guidance unit.

PROJECT PERMITTING: The City of Eagle River will be responsible and pay for the ALL permits required by either the WI DNR or other regulatory agencies. Schmidt's Aquatic will prepare (at no charge) all of the necessary permits including - WI DNR Chemical Aquatic Plant Control Permit Application 3200-004 and/if required, the Large-Scale Worksheet 3200-4A. At the conclusion of the aquatic herbicide treatment, Schmidt's Aquatic will also complete the Aquatic Plant Management Herbicide Treatment Record 3200-111 as required by the WI DNR. Schmidt's Aquatic has obtained statewide coverage for the Wisconsin Pollutant Discharge Elimination System (WPDES) Permit requirements. Schmidt's Aquatic will submit online to the WI DNR all related permits and pay for them at the time of submission. Once the

completed permits are submitted to the DNR, Schmidt's Aquatic will submit an invoice for all the required permits to the City of Eagle River for immediate reimbursement.

The City of Eagle River will work Onterra to ensure all electronic data and mapping information is current prior to the treatment. The City of Eagle River in conjunction with the Onterra, must notify Schmidt's Aquatic in writing confirming the treatment date is approved, and the project can move forward. The City of Eagle River will be responsible for paying all shipping cost/handling to return any of the chemical products that were ordered for the project should the City of Eagle River cancel the project after the WI DNR has approved the permit and the chemical has been ordered and delivered. Schmidt's Aquatic never orders chemical until a permit has been approved, and the client has advised me to order the chemical as they plan on moving forward with the project. Although Schmidt's Aquatic has never had a project cancelled by its client, Schmidt's Aquatic does not carry over any chemicals from year to year.

#### Application Equipment

WHEREAS, the Town of Lincoln is participating in a grant program to establish a Community Wildfire Protection Program (CWPP) and as a requirement of the program, the Town of Lincoln needs to establish a location to accept yard debris to remove potential wildfire sources.

WHEREAS, the City of Eagle River has an existing facility on Elm Drive, that satisfies the requirements of the grant program.

## NOW, THEREFORE, BE IT RESOLVED that:

The City of Eagle River agrees to share the Elm Drive Yard Waste Facility with residents of the Town of Lincoln for the sole purpose of disposing of yard waste. Yard waste is hereby defined as:

Leaves, grass clippings, garden debris, twigs, brush and branches smaller than six (6) inches in diameter. (No plastic bags are allowed).

In return, through the grant program proceeds, chipping will be done at the site on an as needed basis. The Town of Lincoln will provide new signage at the facility noting its purpose and use. Additionally, the Town of Lincoln and the City of Eagle River agree to provide a camera system to monitor the facility traffic and use.

This resolution is effective upon its execution by both parties and will be in effect for two years from that date. This resolution can be terminated by either party with written notice delivered thirty (30) days prior to the proposed termination.

#### April 20, 2023

A public hearing on proposed Ordinance #584, amending Article II, Slow-no-wake zone, Section 102-33(a) Delineated, extending the slow-no-wake zone on the Eagle River from the existing point 700' east of the Hwy 45 bridge, to the area known as the T-docks, was called to order at 5:00PM by Mayor Hyslop.

Roll Call: Ron Kressin, Kim Schaffer, Diane Marquardt and Jerry Burkett. Also in attendance: Becky Bolte, Robin Ginner, Chris Dobbs, Mike Adamovich and Jared Adamovich.

Mayor Hyslop addressed the audience reminding all in attendance that the Public Hearing was for the slow-no-wake zone extension on the Eagle River was not about the wake boat debate that had also made local headlines.

Vic Washelesky, of 173 River Street, spoke on behalf of the original petitioners. A petition was signed by 44 residents of the City of Eagle River and presented to the audience. A map was shown on the big screen to assist his presentation. Washelesky addressed the audience with the petitioners concerns. The third paragraph of the petition was referenced by Washelesky, that read; "Wisconsin State Statutes allow the City of Eagle River to enact local boating regulations in the interest of public health, safety, and preservation of natural resources. Because statutes regulate watercraft on lakes but not rivers, the current conditions create safety hazards and unnecessary erosion of the riverbank. On a lake, boats and PWC's (personal watercrafts) must be at no wake speed within 100 feet of a swimmer or a pier. No such requirements exist on a river. The only process to remove this safety hazard is to enact a no-wake-zone". Washelesky stressed the petitioners safety concerns and discussed two possible options; Option #1 to extend the slow no wake from it's current point of 700' East of the Hwy 45 bridge to a line at 328 E McKinley on the north shore and Trees for Tomorrow on the south shore, and Option #2 to extend the slow no wake from it's current point 700' East of the Hwy 45 bridge down to the City limit near the T-docks. Washelesky stating he believed Option #1 was critical, and the reason for needing this change now was due to the area being built up, more congestion the past few years, bigger boats, personal watercrafts that can go 40 mph, and having a couple of boat rental businesses in the area leading to less experienced boaters on the River. Commitment to pay for the buoys and signs was presented by Washelesky and he stated that the Sheriffs department already patrols the area. The upside in enacting the extension would be for safety and for silent water sport enthusiasts to use the river for kayaking, canoeing, and for smaller boats. Washelesky ended his presentation at 5:15PM

Hyslop asked attendees to remain respectful of one another and stay on the topic being presented, with comments to address only what was within the City jurisdiction. To keep things moving along, it was requested that those who wish to address the Council, try to keep their comments to two minutes. Burkett requested that City of Eagle River residents were allowed to address the Council first.

The audience was allowed to address the Council, uninterrupted, by a show of hand to speak. Nineteen people verbally addressed Council and an additional ten written comments were received and supplied to all Council members. Those who spoke in favor of the change: John Wilhelm, Howard Wolf, Ken Delaney, Bill Morgan, Marvin and Carol Radloff, Robert Dow, Joe Orlovsky, Ted Wydeven (in favor only for option #1), Tina Aiello, (in favor only for option #1). Those that spoke in opposition: Jim Tidball (concerns of SNW by T-docks) Dean Winger, Todd Achterberg, Jack Stoskopf, Ken Anderson, Dan Krause, Jared Adamovich. Rob Hicks spoke stating in his experience, nobody seemed to obey the SNW zones and felt enforcement was the bigger concern. A letter from DNR Recreational Warden, Northern Region, Robin Miller was recited by the Clerk as a response to a question that arose by Jack Stoskopf. The DNR letter summarized why the WDNR did not support extending slow no wake on the Eagle River to the T-docks, also stating the DNR did not have jurisdictional control. The original petition requesting the SNW extension was signed by 44 City of Eagle River residents. The public hearing sign-in sheet, recording 40 attendees, with some having also supplied written comments, was supplied to Hyslop at the beginning of the hearing.

At 6:03PM, Mayor Hyslop confirmed with the audience that everyone who wished to address the Council had been given the opportunity to speak.

Mayor gave the floor to City Police Chief, Chris Dobbs. Dobbs stated she agreed with Tidball's concerns about the T-docks. Dobbs stated that she had created mapping overlays from multiple years, and with her eye, she could not see where erosion was apparent. Dobbs went on to explain to the audience that although she agreed with the need for additional enforcement staffing on the river, shortages of law enforcement officers and budget constraints prohibit it from happening. Dobbs stressed that law enforcement must prioritize the needs of the community to stay within the confines of staffing shortages and budget shortfalls, stating that there will not be an immediate response to complaints on slow-no-wake complaints.

Kressin, Alderman for District 4, disclosed that he lived on the Eagle River, 320 McKinley, and that he had signed the original petition. He reported his experiences with more traffic on the River and bigger, faster boats, including boats with 200 or 300hp motors. Kressin shared a close call experience with another boat flying past and coming within a foot of his pontoon while trying get his boat into his lift with grandkids on his pontoon. Although he understands the buoys will not be a complete fix, his experience on the Chain is that the vast majority of people will obey a slow-no-wake area. Kressin stated he now sees the argument not to extend the slow-no-wake zone down to the launching area at the T-docks but extending the buoy down to the area around Tree's for Tomorrow was a yes for him. Clerk note: Ginner confirmed with the League of Wisconsin Municipalities legal counsel, Claire Silverman, Kressin did not need to recuse himself from voting as there was not a financial gain/loss associated with the vote.

Schaffer, Alderperson for District 3, 220 Spruce Street, stated that although she did not own a boat, she grew up on Anvil Lake, stating that the safety concerns addressed happen everywhere. Schaffer pointed out the influx of people due to Covid, questioning if we will continue to have such an influx. The noise of boats in the late hours can be heard as far as her office on 3<sup>rd</sup> Street. There is a high concentration of people on the chain and her concerns lie in not only protecting the safety of the users but also in not being detrimental to people heading west. Although Schaffer agrees that the river to the west, towards Watersmeet Lake end, may be affected, the City cannot control that and residents would have to take it up with the Town of Lincoln to address it. Schaffer stated she would not support extending the slow-no-wake to the T-docks but would support extending to Trees for Tomorrow, hoping it would help with safety and not be detrimental to the area, stressing it is her job to be responsible to the taxpayers.

Marquart, Alderperson for District 1, 1st Street and Maple St, stated she also hears the loud boats from her house. Her concern was safety, stating that rentals, especially personal watercrafts, often have uneducated drivers. Marquardt sees the point of a no on the extension down to the T-docks. Marquardt suggested trying the extension to Trees for Tomorrow area for the season and reassess to see if the situation needs to be adjusted.

Burkett, Alderman for District 2, stated he has had 29 years on Council, and that he was currently the Chair for Vilas County and the Chair of Law Enforcement. Levy limit restraints prevent him from hiring anybody. Burkett reported that a resolution is being brought to Vilas County to add two school resource officers, ensuring every school in Vilas County is protected. School safety is a bigger priority than slow-no-wake. The County will be able to use those two officers during the summer months, which will increase the boat patrol presence. Vilas County has 1326 lakes and every one of them want a cop. Burkett summarized the problem at hand as trying to come up with a solution for the bottom 2% of rude boaters. He noted that of the initial speakers that live on the stretch of the Eagle River in question, no one was against the slow-no-wake extension on the premise of safety. The extension may be an inconvenience but is a worthwhile inconvenience for safety. Burkett asked, that in this neighborly situation, if all present could live with the slow-no-wake being extended from the current point, 700' East of the Hwy 45 bridge, to Trees for Tomorrow, for one year only and re-assess, asking for a show of hands in

support, with many hands in the crowd raising. Burkett stated people should report to Council, the Eagle River Police Department, or the Vilas County Sheriff's Department to compile records supporting/or disproving the effectiveness of the slow-no-wake zone extension solution. Burkett asked how many feet would be involved in the extension to Trees with Ginner supplying 1900'. Burkett stated that an increase of approximately 1900' of slow-no-wake is an amount he could live with, stating that this was government at its finest, coming together to find a solution to a problem.

Jared Adamovich, City Public Works and Parks Department, stated that he was one in charge of putting the buoys in and suggested the need for four buoys to mark the area, adding conditions will probably lead to the first buoy being damaged each year and would need to be replaced annually.


Mayor Hyslop summarized with, "If you make a decision, and it turns out to be the wrong decision, you can make another decision". Mayor commended the crowd for the respectful manner displayed during the hearing.

Motion by Kressin,  $2^{nd}$  by Marquardt to adopt slow-no-wake ordinance #584, extending the slow-no-wake zone from the current point 700' east of the Hwy 45 bridge, to the area at Trees for Tomorrow on the south shore and the area at 328 E McKinley on the north shore, and a minimum of four buoys to mark the area, and having a sunset clause to reassess after one year. Carried on a roll call vote, all.

Motion by Burkett, 2<sup>nd</sup> by Schaffer to adjourn the meeting at 6:30 pm. Carried all.

## What is wake surfing?

It is surfing on a massive boat wake, close behind the boat, without using a rope. It needs to be done in deep, large lakes to avoid damage. The waves can be 3 to 5 feet high. Note that the type of boat used to make these waves is

totally different from a ski boat. Wake surfing boats plow the water at about 10 mph, unlike waterskiing boats, which ride on a plane to avoid big wakes.

## Why is wake surfing harmful?

The massive wakes can capsize canoes, kayaks, stand up paddle boards, other boats and water skiers. While surfing, the bow of the boat is so high it can be hard for the driver to see a boat in front of them; this is clearly dangerous. The high wakes can crash against shorelines, damaging docks and moored boats. When surfing, the propeller can be 4' deep and at a downward angle. The propeller wash can stir up sediment, and damage or uproot vegetation, impacting the lakebed greater than 20' deep. When sediment is stirred up, many species including loons are unable to locate their food sources. We love our loons. Loons' eggs are inches above the water; large wakes can wash away these eggs. Phosphorus freed from the lake bottom can fuel algae and bacteria blooms, creating fish kills and noxious odors. Extensive algae blooms in small lakes impacts home values.

#### What about invasive species?


Wake boats carry thousands of pounds of lake water as ballast. Numerous studies show that even after emptying the tanks, there is still an average of 8 gallons of lake water in the ballast compartments. Invasive plants and organisms can survive many days in the tanks, only to be released into the next lake. Aren't there already laws protecting us and our lakes? Wisconsin's hazardous wake statute 30.68 protects people and property. If wakes damage your shore, boat or dock, and you can prove which boat did it, that statute can help.

#### But there are NOT laws that protect the lakes themselves, fish and wildlife?

No state law protects the environment of the lake from damage by massive wakes, prop wash or invasives transfer because of wake surfing. Presque Isle's ordinance committee, at the request of a previous town board, did extensive research (see Resources) and proposed an ordinance to defend lake health in that portion of Vilas County. It has not been brought to referendum. Four townships in Sawyer County have passed such a protective ordinance (see Resources).

#### The Northwoods economy depends on the quality of our lakes.

If swimmers, water skiers, anglers, pleasure boaters, kayakers and others can no longer enjoy our lakes, then tourism, property values and local business income will plummet.

#### **CURRENT ACTIVITY:**

During the month of February our officers investigated 84 offenses. A total of 12 cases were cleared by arrest or referred for prosecution. A total of 3 new cases were added to our active investigation caseload. A total of 13 cases were placed in inactive status and 0 incidents unfounded. The remaining cases have been closed without arrest or referred for review to the District Attorney, Juvenile Intake or another agency. Our active investigation caseload is presently 32 cases under continued investigation. In addition to calls with sufficient

#### **CURRENT ACTIVITIES:**

We have a Concealed Carry coming up March, 2024. There are still a few seats if anyone is interested in attending.

We are in the midst of reassembling our Chaplain program within the department. Chaplains play an integral role in the department and community. Police chaplains provide confidential support in several key areas of law enforcement and in the communities they serve. These areas include but are not limited to officer wellness and support, spiritual support, and community-police engagement.

In addition to supporting officers and first responders struggling with issues such as burnout, stress or trauma, Chaplains also assist officers with some of their duties. These can include tasks like death notifications, crime victim support and homeless outreach. Chaplains' support and encourage people of all religious faiths and are familiar with beliefs across many different cultures.

Our Chaplains are in good standing with their organizations, are active in the ministry or in a related ministry with their own denomination and exhibit and maintain high spiritual and moral standards. A key element of a chaplain's qualifications and qualities for service with a law enforcement agency is his or her willingness to be actively involved in learning and development activities, such as the training programs offered by ICPC and their agencies.

Four of the five chaplains recently attended the International Conference of Police Chaplains (ICPC) regional training to receive additional knowledge and skills to complement their backgrounds to better assist our area communities, first responders and the team members of the Eagle River Police Department. Our Chaplains are also trained through the Eagle River Police Department and serve as voluntary community leaders. Christine Daring and Rob Dixon will also be attending the Vilas County Sheriff's Department Citizen's Academy which starts soon so that they have will a greater understanding of the day-to-day operations of law enforcement, needs of officers/first responders and the needs of our community.

## Admin/General

I had to do a lot more research for the TID audit for CLA regarding expenditures and allocations dating from 2015 through 2018. As before, the information has been submitted to CLA and I'm awaiting additional feedback or additional requests for information. It was a pretty involved research and analysis project, but I feel the information I provided was the cleanest and most accurate available. I anticipate having the final adjusting entries to fix the TID books soon.

CLA was on-site for our audit in mid-February. It went MUCH smoother than last year. They do not anticipate any delay in getting our financial statements to us by early summer.

When I was at the WCMA conference this past week, during the legislative update session the League of WI Municipalities reported that the parameters for the innovation grant still have not been finalized. This was the grant to support combining EMS in at least part of Vilas County. We're a shoo-in for this funding if/when they release the parameters, but my understanding is they won't be released yet in 2024 because it's an election year. So, we'll hold out until 2025 and will be ready to jump on the grant application as soon as it's released.

I've received the first draft policy from Baird in regard to Uniform Grant Guidance. This was first on the list as it's required by USDA Rural Development. I'll be reviewing this with Baird, and we hope to have it on the agenda for approval at the April meeting, once USDA and Steve G have had a chance to review. We're starting to move our way through the list! It's going to be a lengthy process, but I know the three of us here at City Hall will feel better when we have policies and procedures in place. No more shooting from the hip.

#### Departments/Committees/Commissions

<u>Airport</u> – We have two potential communication tower projects within the City of Eagle River's height limitation zoning ordinance purview. I have yet to receive any kind of an application for a Planning Commission hearing from either. One project is on Skinner Road, just south of 70/17, and the other is north of town at 45/17. We have sent letters to the FAA objecting to both because of the impact on our approach altitudes. I believe Lincoln and Washington have done the same. Stay tuned for more developments on both projects as they approach the City for permission.

<u>Beach</u> – I've been in touch with Scott Foster at the high school to see if we can post a job listing there for new lifeguards. I anticipate 3-4 of our existing lifeguards to return, but we could use a couple new kids. I think I'm going to post the job opening in the paper earlier this year to give potential candidates an opportunity to get certified at the YMCA.

<u>Golf Course</u> – The lease for the restaurant has been finalized, effective March 1, so Blaze can get in there are start preparing to open. We're having the carpets cleaned in mid-March, the water has been turned on in the Clubhouse, and Tony's been in the ProShop working on opening up as well. When Kyle returns from his pre-scheduled vacation (who could have

guessed the weather when he planned his trip?!?) he'll call his troops back in to start getting the course in shape to open up.

Letters for the season passes have been sent out, and as soon as Kyle announces an open date, I expect we'll start seeing seasonal revenue coming in for passes. We're going to have a long season this year, so I hope Tony breaks his \$1 million goal!

Bids for the Media/Marketing services are due on the 22<sup>nd</sup> of this month. So far, I have only received one call of interest from a new company. I expect Swisher to submit a bid, so we'll wait and see what comes in by the deadline.

**Public Works** – See attached list for DPW activities from February 2024.

**Zoning/Planning** — We didn't have a meeting for the Planning Commission in February. Our March meeting will include continued conversation about the Tamarack Street extension and discontinuance, and an updated ordinance on the leash law here in the City. Steve G will attend the March meeting so we can move both of these issues forward without further delay.

## 2024 Projects

**Project Funding** – I talked with Mike and John from Light & Water about our 2025 project year. It's going to be an expensive year, and they were concerned about funding options. When I was at WCMA I talked with Brad Viegut from Baird, and I'll be following up with him on options to cover not only the Third/Spruce project, but their water town rehabilitation project as well. I hope to have something together to present at the April meeting in terms of options. We could bundle our 2024-2025 projects into a municipal bond, which would give us a 30-year repay option, which would lower the annual cost for both the City and L&W. Stay tuned – more to come on that next month.

Rotary Square — I've been working with Rotary and Detective Rossing regarding the camera installation at Rotary Square. We will have three bids for installation of the cameras — with one to be approved by the Council. Ryan believes he can get a grant from Walmart that will cover 90% of the installation, so it shouldn't cost the City much at all. Having the cameras there will help with not only monitoring the Square, but with traffic during the busy months on Wall Street. We had to go out for bid because the young man the PD has been working with on all of our cameras vanished without notice to take a job out of the area. So, we sought out new contractors, and the bids varied widely. Light & Water will work with Ryan to remove the existing cameras, and the contractor will come in and re-install them in the updated locations.

<u>2023 Silver Lake Milfoil</u> – We finalized the lake study grant with the DNR. We had to issue a couple refunds to the lake association and Town of Lincoln because they overpaid their share on the study grant. So far, we've received three bids for treatment of the lake. The bid deadline is March 11<sup>th</sup>, so I will have additional information for you at the Meeting.

<u>2024 Chipseal Bids</u> – I asked Moe and Tom to take a tour of the City and provide me with an updated list of streets that need to be chip sealed. The previous list I was working from was largely complete. Using this latest information, I've completed the bid packet for the 2024 chip

sealing, which will be released in late March. Bids will be due in early May so we can get on the schedule early. That's worked out well for us the past couple of years, and I'd like to keep that schedule going. It's better to get the work done early instead of fighting the weather should fall hit early.

**2025** Spruce/Third Project — In April we'll be having a public hearing for the CDBG grant application for this project. It's a requirement to apply for the grant. MSA will be there to conduct the hearing.

<u>2024 Silver Lake Road Project</u> – We still haven't heard back from WI DOT on the MSID funding requests. Troy from the Highway Dept said we should hear back in late March or early April. I will keep you all updated.

McKinley – I asked Phil from MSA to work up an estimate to re-construct McKinley from Railroad all the way to the City limits, including utilities, and improvements to stormwater drainage. It's a <u>hefty</u> estimate, but I'm going to use it to write an appropriations request on the next fiscal budget. In reviewing past years' federal budget appropriations for Wisconsin, I've identified several road construction projects around the state, which gives me hope the ask will be successful. Unfortunately, the project doesn't qualify for any real funding in terms of traditional grants because of the real estate values in that area. This is a hail Mary attempt for funding, so I'll be working with Senator Baldwin's office on the submission. Otherwise, we're going to have to do bond funding for 30 years or something to pay for it. But the road is bad and needs to be addressed in the next few years at most.

## FROM THE DESK OF CORY HOFFMANN, DEPUTY CLERK/TREASURER MARCH 2024 CITY COUNCIL MEETING REPORT

2024 has started with a bang!!

CLA auditors were here for one week in February for the preliminary 2023 audit. This audit went smoothly and with only a few issues.

- I had been posting the health and life insurance along with the WRS the same way it was posted in Quickbooks yet was advised that Workhorse takes care of the expense side of posting when payroll is performed, so I will post to the accounts payable account for now on. That will be one of the auditor journal entries I will need to perform for the 2022 audit.
- I was finally able to reconcile all the 2023 bank statements except for the golf course operating account. I had performed the reconciliation 4 times on this account, and now it is in the hands of CLA auditor Riley Hutter to find the difference. Both he and I are pretty sure it has to do with the transition between Quickbooks and Workhorse. Another set of eyes to look at it.

I am finished with filing all the items that were on the table in the office from the previous treasurer. I have items to be filed in the basement and the 2022 banker boxes will be moved to the safe. Items in the safe will also be moved to the basement when time permits.

Workhorse is working out to be an awesome accounting system.

The 2023 Real Estate Tax payments were completed on January 31st for the city. Both the January and February settlements with the county were done with no discrepancies. We are still taking in personal property and pet licensing during the rest of the year. The new tax payment system (ASCENT) that the county went with is very easy and more efficient to use.

Choice Tel sent out the February invoices and were not received in our office until the due date of February 15th. They were advised of this and extended the payment date to February 21st.

Advised the Police dept administration assistant along with Tony and Kyle via an email to make sure they get the invoices due back to me as soon as possible to be paid. I have been receiving them back from the departments after the due dates.

I am in the process of taking the required training to help Becky with elections.

I am also in the process of obtaining my notary from the Wis Dept of Financial Institutions.

## Clerks Report February 2024

<u>Elections</u>: The past month has been heavy with preparations for the April 2 – Spring Election & Presidential Preference Primary. I have hosted training for the Chief Inspectors and New Poll workers throughout the past month. I will host one more training course the week before the election for all poll workers scheduled to work the April 2 election. Special Voting Deputies will visit our care facilities on March 12. We have added Legacy to our SVD served facilities and they have been great to work with. The Vilas County Deputy Clerk put on another election round table training for all Clerks and Chief Inspectors in the area. There have been some changes in what the County Clerks office is doing for us as reliers and we are working through some procedural changes to try to improve efficiency for all municipalities and the county.

I have submitted a scholarship application to the Municipal Clerks Association for my third year at the Clerks Institute.

## Liquor Licenses:

We will have the Eagle River Golf Course Restaurant liquor license application on the agenda for Blaze Champeny, Turkey's Clubhouse.

St. Germain will have the possible sale of a reserve combo liquor license on their March 11 agenda. The owners of Americann (Formerly Super 8) and Days Inn are aggressively pursuing the purchase of two Class B combo licenses (which we have none). If their Board does approve the sale, the law allowing for the purchase would not go into effect until May 2024.

Operators Licenses: License applications continue with minimal new applicants.

<u>Permits/Licenses</u>: We have another batch of 2024 event applications on the agenda. While most are annual events, we do have a couple of new ones.

Veterans Resource Center – Come to the Coop to Support our Troops, Aug 14, 2024, at The Square. This event is replacing Paul Bunyan Fest. They will be selling food (Grilled ¼ chicken, potato salad, and roll for \$10.00) and beer with all proceeds going to support area vets.

Tri-County Council on Domestic Violence and Sexual Assault — Rising from the ashes (a burn ceremony in honor of Sexual Assault Awareness Month), April 24, 2024, at Vilas County Fairgrounds. The Eagle River Fire Department has been contacted and will be the ones to issue the burn permit. The fire department will be supplying the burn pit rings. The organizers have been in contact with Deb Clemens of the Vilas County Ag Society for approval.

Eagle River Revitalization - Young Entrepreneur Market (YEM), June 29, July 18, and August 15, 2024, at The Square. They are looking to host a youth (ages 10-17) market for crafts, services, and entertainers.

Eagle River Revitalization – Summer Kickoff Event, June 29, 2024, at The Square. The event is to support The Square Maintenance fundraising. The application includes Chalkscape which requires the use of the sidewalks on and around The Square for public art using washable chalk. There will be food trucks and a beer garden. The food trucks will be part of the event and not permitted through the City but through the event application and Eagle River Revitalization.

All events are compiled/updated into a document that is shared with all department heads, ERRP, the Chamber and the fire department for planning.

<u>NAN Refinance:</u> The rate was finalized at 4.11% with BAIRD financial and closing documents received from bond council Quarles and Brady, have been signed and returned. The settlement date is March 26 with funds being wired to pay off the NAN to be done April 1, 2024.

Garbage and Recycling: The final tonnage numbers have been supplied for the 2023 Recycling Grant Annual Report, updating the estimated application from the previous year. Republic reported the actual came in at 134.46 tons. The application will be returned before April 12, 2024, deadline to Vilas County Zoning and Planning for electronic submittal to the DNR.

Spring Yard Waste cleanup will again be held in May after the schools Earth Day cleanup, the date is still being worked out. We will continue to notify our residents on the webpage and via a flyer in the digital and paper copies of the ERLW bills.

<u>Insurance:</u> We have had one new worker's comp report of injury and one liability claim. I have continued with follow-ups on previous claims that are still open.

<u>Special Assessment Requests</u>: I have had six Special Assessment Requests since the previous council meeting.

<u>Open Records Requests</u>: We have received two small open record requests this month, one regarding tax exempt property and one for retirement benefits paid.

Room Tax: Room tax for the 4th quarter of 2023 is fully collected and settlement information has been forwarded to the Room Tax Commission Treasurer. The numbers for the annual report for 2023 are finalized with the City of Eagle River retaining \$10,407 in 2023 (10%), down slightly from \$11,045 in 2022.

<u>Department of Revenue Form Filing</u>: Room Tax Annual Report for 2023, DOR form SL-304 has been completed and will be filed with the department of revenue before the May 1, 2024, due date.

Tax exempt certification forms, PC-220, were mailed to tax exempt property owners on February 15. Completed forms have been coming in for processing with the deadline for return to the City being the end of March. The City charges \$25 to process a single parcel and \$35 for those that have multiples.

Meetings: Following the February meetings, all licenses and permits were produced, mailed/emailed to the applicants. February council meeting minutes were published. All Clerk items were added to the March agenda. All Clerk supporting documents for the March Finance and City Council meeting were prepared and supplied for Robins meeting binder. Draft minutes were completed for the Finance Committee and Regular Council meetings. All Eagle River agendas were posted onto the bulletin boards, sent to the email distribution list and posted onto the website. All Vilas County, ERRP, NPSD, Airport, and LVG supplied agendas were posted on our bulletin board.

<u>Taxes/Assessor:</u> Associated Appraisals has started the interim market revaluation with the last invoice reporting 13.75% complete.

<u>City Hall:</u> Spring maintenance scheduling has begun. City Hall will have carpets cleaned by Eagle Cleaners after the April election. We are on the schedule for window cleaning. The garage heater at the PD was repaired by CAMCO. CAMCO has submitted an estimate for replacement that will be presented for the 2025 budget.



No person having in his possession or under his control any animal or fowl shall allow the animal or fowl to run at large within the city. No person shall keep within the city any animals or fowl, except domesticated pets, without a permit issued by the city. In issuing a permit for other animals such as horses, cows, pigs, pigeons and the like, the city shall consider the number of such animals expected to be kept, the location, and the likelihood of a public or private nuisance being created.
