#### **Permit for Street Banners and Portable Signs**

A building permit is not required for street banners and/or portable signs advertising <u>public entertainment or non-profit organizational events</u>. However, prior approval must be obtained from the City Council specifying the banner/sign and the specific location. No sign may be erected for a period exceeding ten (10) days prior to the event or three (3) days following the event. Proof of liability insurance must be provided to the city clerk prior to erecting the banner/sign.

City of Eagle River must receive from the Organization or Wisconsin D.O.T. written permission from the Wisconsin Department of Transportation (note: attached application) before banner may be erected.
