Treasurer confirmation that all bank accounts are reconciled: Hoffmann reported most of July is reconciled.

Treasurer report of any and all late payments and penalties: Hoffmann reported two \$30 charges from a Positive Pay error.

August Financial Review: Hoffman stated 2023 post audit journal entries have been entered into the accounting system and presented financial statements for the City and the Golf Course.

Review and approval of Accounts Payable for City and Golf Course: *Motion by Jerry Burkett, 2nd by Marquardt, to recommend payment of presented City and Golf Course payables to City Council. Carried on a roll call vote, all.*

A meeting of the Common Council of the City of Eagle River was called to order at 6:00PM by Mayor Hyslop.

The Pledge of Allegiance was led by Diane Marquardt and was recited by all present.

Roll Call: Dan Dumas, Kim Schaffer, Diane Marquardt, and Jerry Burkett. Also in attendance: Robin Ginner, Becky Bolte, Cory Hoffmann, Chris Dobbs, Adam Ross, Mike Adamovich, Mike Sanborn, and Kyle Anderson.

Motion by Burkett, 2nd by Schaffer to approve the minutes of the 8/15/2024 Finance Committee and Common Council meetings and the 8/22/24 Special Common Council meeting and 9/5/2024 Board of Review meeting minutes. Carried, all.

A) Street Closing/temporary sign/amplification/display of goods permits: Todd and Tracie Tappy presented requesting parking space and sidewalk closure for dump trailer placement for demolition of exterior and interior of a building located at 106 E Wall St. *Motion by Schaffer, 2nd by Marquardt to approve parking and sidewalk closure in front of building at 106 E Wall St for the placement of a 40 yard dumpster for a maximum of seven days, Wall St placement of a dump trailer as needed during demolition period, and sidewalk closure after CranFest. All closures for demolition at the discretion of the Chief of Police. Carried, all.*

Margelofsky of ERRP presented the new Young Entrepreneur Market (YEM) event requesting permit for display of goods, amplifying device, and temporary signs at the Square on October 4, 2024. *Motion by Schaffer, 2nd by Burkett to approve ERRP Young Entrepreneur Market permit for Plaidurday, display of goods, amplifying device, and temporary signs for October 4, 2024, from noon to 3:00PM as presented. Carried, all.*

B) Operator's licenses: REGULAR: Sherry Ankebrant, Emily Anderson, Connor Killion. *Motion by Burkett, 2nd by Dumas to approve all regular operators licenses as presented. Carried, all.*

C) MSA Monthly Update: A written update was provided by Kriesel including an update on the 2024 Street Improvement Program, the Silver Lake Road Project, and the E Spruce and N Third Street Project. Pay Request #1 for Maple Street Resurfacing Project, \$59,513.23, Pitlik & Wick was presented. *Motion by Burkett, 2nd by Schaffer to approve Pay request No 1 to Pitlik & Wick for a total of \$59,513.23 for Maple Street resurfacing. Carried on a roll call vote, all.*

Pitlik & Wick Change Order #2 to add 10" of crushed aggregate base to the Birch Street resurfacing project, was presented for a total cost of \$42,266, for the area of Birch Street between Spruce Street and Maple Street. Discussion on soil borings. *Motion by Schaffer, 2nd by Marquardt to approve Pitlik & Wick Change Order No 2 adding 10" of aggregate base to Maple/Birch Street project on Birch Street between Spruce Street and Maple Street for an increase of \$42,266 to original contract. Carried on a roll call vote., all.*

D) Planning Commission Recommendations:

Premier Eagle River, LLC architectural plans to construct a multi-family housing complex consisting of up to 36 units, on Parcel #221-1060-05, described as NW-NE, Sect. 34, T40N,R10E, PRT NW NE EXC 507081,547546,593411. The parcel is located at the northeast corner of US Highway 45/East Pine Street, Wall Street, and State Highway 70 East. Burkett excused himself from discussion and Chambers as he has actively worked with developers. Schaffer presented the Planning Commission recommendation. Discussion. *Motion by Schaffer, 2nd by Dumas to accept the Planning Commission recommendation and approve Premier Eagle River, LLC architectural/lighting plan to construct a multi-family housing complex consisting of up to 36 units, on Parcel #221-1060-05. The parcel is located at the northeast corner of US Highway 45/East Pine Street, Wall Street, and State Highway 70 East. Carried on a roll call vote, Ayes: Schaffer, Dumas, Marquardt. Nays: None, Burkett abstaining*

Burkett rejoined the meeting.

Northwest Counseling and Guidance Clinic's request for a conditional use permit to establish a space from 8 am to 4 pm, Monday through Friday, to provide children and adolescents with outpatient day treatment programming at 221 S. Fifth Street, Eagle River, per Ordinance 106-443 (9): Uses permitted by conditional grant: Group care and family care facilities, nursery schools. The property is described as Sect. 33, T40N, R10E, LOT 9 BLK 2 OF J F HABRICH FIRST ADDN F14. Schaffer presented the Planning Commission recommendation and resident input from the public hearing. Discussion. *Motion by Schaffer, 2nd by Marquardt to accept the Planning Commission recommendation to approve Northwest Counseling and Guidance Clinic's conditional use permit to establish a space from 8 am to 4 pm, Monday through Friday, to provide children and adolescents with outpatient day treatment programming at 221 S. Fifth Street. Carried on a roll call vote, all.*

Jon T. Keckeisen request for a conditional use permit to place one 20' storage container at 1078 E. Wall Street for no more than one year, per Ordinance 106-473 (10): One single shipping container, painted a single color, all advertising removed, subject to existing accessory structure set-backs. The property is described as NW-NW, Sect 34, T40N,R10E, PRT NW NW. Schaffer presented the Planning Commission recommendation and resident input from the public hearing. Discussion. *Motion by Schaffer, 2nd by Burkett to accept the Planning Commission recommendation to approve Jon T. Keckeisen's conditional use permit to place one 20' storage container at 1078 E. Wall Street for no more than one year, per Ordinance 106-473 (10). Carried on a roll call vote, all.*

Eagle River Revitalization's request for placement of new shed at the east side of the Ohio/Michigan intersection and to add additional electrical peds throughout the site for use by Farmers Market vendors. Schaffer presented the Planning Commission recommendation. Discussion. *Motion by Burkett, 2nd by Schaffer to postpone discussion until Michigan Street residents are personally notified of proposal. Carried, all.*

E) Approval of Developer Agreement for Pre-3/Premier Eagle River, LLC 36-unit apartment complex development. Ginner stated the supplied agreement is not needed, confirmed by Attorney Garbowicz. No action.

F) Presentation by Jerry Burkett regarding sale of Park Street/Riverside Park property by Vilas County Burkett stated the property at the Vilas County Fairgrounds/Riverside Park is owned by Vilas County and that Vilas County Forestry is in control of that land. He presented that Vilas County was looking at selling approximately

900' of frontage on the North side of Park Street behind the fairgrounds. An informal study showed Riverside Park was highly underutilized and proposed the possible sale of the frontage property to generate revenue and future taxes. Burkett confirmed he was not looking to shut down the Vilas County Fair. Discussion. *Motion by Dumas, 2nd by Schaffer to extend City of Eagle River support to work together with Vilas County to investigate future use of the property on the North side of Park Street at Riverside Park. Carried on a roll call vote, all.*

G) Eagle River Revitalization Program:

Replacement of decorative hanging lights along Wall Street and Railroad Street. *Motion by Schaffer, 2nd by Marquardt to approve ERRP request to replace decorative hanging lights along Wall Street and Railroad Street, with approval from ERLW Utility Manager, Mike Sanborn. Carried, all.*

Parking for Farmers Market – recommendations for street parking. Margelofsky presented the need for additional parking at the Farmers Market. Discussion, no action.

Resolution #1043 to allow Eagle River Revitalization to apply for a Small Business Development Grant on behalf of the City. Ginner and Margelofsky presented the grant. Discussion. *Motion by Schaffer, 2nd by Dumas to postpone discussion/action until the October City Council meeting when more information on the grant can be supplied by Margelofsky.*

H) Golf Course Updates from Golf Pro and Greens Superintendent: Greens Superintendent Anderson reported Sunday October 13 is the scheduled course closing date.

Golf Pro Sable provided written financial and marketing reports.

I) Golf Course Clubhouse Repairs Update

Review quote for approval from Hite House Builders for roof replacement project, \$49,000.00, plus additional recommended work at an additional \$6,500.00. Discussion. Ginner presented the additional \$6,000 items are included in the bid package so that add-on can be disregarded. *Motion by Burkett, 2nd by Schaffer to approve the Hite House Builders quote for roof replacement at the Golf Course Clubhouse, 457 McKinley, for \$49,000. Carried on a roll call vote, all.*

J) Department of Public Works: *Motion by Burkett, 2nd by Dumas to approve Foley's Tree Service proposal to grind Elm Drive stump dump, total expense of \$5,800 to be shared 60/40, Eagle River/Town of Lincoln for this grind. Carried on a roll call vote, all.*

Motion by Burkett, 2nd by Dumas to approve the purchase of five new tires for grader, Pomp's Tire Service, \$12,547.49. Carried on a roll call vote, all.

K) *Motion by Schaffer, 2nd by Marquardt, to approve the Entrance Technologies proposal to replace ADA automatic door opener at back City Hall door, \$2,917.20. Carried on a roll call vote, all.*

L) Ward 1 Representation

Diane Marquardt, Alderperson District 1 – Ward 1, provided her resignation effective 9/30/24. Motion by Schaffer, 2nd by Dumas to appoint Vic Washelesky as representative for Aldermanic District 1, Ward 1 to the Eagle River Common Council to fill upcoming Aldermanic seat vacancy, for term ending April 2025. Appointment effective October 1, 2024. Carried on a roll call vote, all.

AMENDING CROSS CONNECTION
CHAPTER 90, ARTICLE II, SECTIONS 90-31 to 90-38
ORDINANCE NO. 589

TO PROVIDE A PROGRAM FOR PROTECTING THE PUBLIC WATER SYSTEM FROM CONTAMINATION DUE TO BACKFLOW OF CONTAMINANTS THROUGH THE WATER SERVICE CONNECTION INTO THE PUBLIC WATER SYSTEM

WHEREAS, Chapters NR 810, NR 811, and SPS 382, Wisconsin Administrative Code, require protection for the public water system from contamination due to backflow of contaminants through the water service connection; and

WHEREAS, the Wisconsin Department of Natural Resources requires the development and implementation of a comprehensive cross connection control program to effectively prevent the contamination of potable water systems;

THE COMMON COUNCIL OF THE CITY OF EAGLE RIVER, VILAS COUNTY, WISCONSIN ORDAINS AS FOLLOWS:

CHAPTER 90, ARTICLE II – CROSS CONNECTIONS, SECTIONS 90-31 to 90-70, IS RESCINDED AND REPLACED WITH THE FOLLOWING UPON ADOPTION OF THE COMMON COUNCIL:

Sec. 90-31. - DEFINITION OF CROSS CONNECTION. A cross connection is defined as any physical connection or arrangement between two otherwise separate systems, one of which contains potable water from the City of Eagle River's public water system, and the other of which contains water from a private source, water of unknown or questionable safety, or steam, gases, or chemicals, whereby there may be a flow from one system to the other, with the direction of flow depending on the pressure differential between the two systems.

SPS means Safety and Professional Services.

NR means Department of Natural Resources.

Sec. 90-32. - UNPROTECTED CROSS CONNECTIONS PROHIBITED. No person, firm, or corporation may establish or maintain, or permit to be established or maintained, any unprotected cross connection. Cross connections shall be protected as required in ch. SPS 382, Wisconsin Administrative Code.

Sec. 90-33. - INSPECTION. The water utility may inspect, or arrange for an inspection of, property served by the public water system for cross connections. The frequency of inspections shall be established by the water utility in accordance with Wisconsin Administrative Code. Any unprotected cross connections identified by the inspection shall be promptly corrected. Failure to promptly correct an unprotected cross connection shall be sufficient cause for the water utility to discontinue water service to the property, as provided under 90-36 of this ordinance.

Sec. 90-34. - RIGHT OF ENTRY. Upon presentation of credentials, a representative of the water utility shall have the right to request entry, at any reasonable time, to a property served by a connection to the public water system for the purpose of inspecting the property for cross connections. Refusing entry to such utility representative shall be sufficient cause for the water utility to discontinue water service to the property, as provided under 90-36 of this ordinance. If entry is refused, a special inspection warrant under Section 66.0119 of the Wisconsin Statutes, may be obtained.

Sec. 90-35. - PROVISION OF REQUESTED INFORMATION. The water utility may request an owner, lessee, or occupant of property served by a connection to the public water system to furnish the water utility with pertinent information regarding the piping systems on the property. Refusing to provide requested information shall be sufficient cause for the water utility to discontinue water service to the property, as provided under 90-36 of this ordinance.

Sec. 90-36. - DISCONTINUATION OF WATER FOR VIOLATION. The water utility may discontinue water service to any property wherein any unprotected connection in violation of this ordinance exists, and take other precautionary measures deemed necessary to eliminate any danger of contamination of the public water system. Water service may be discontinued, however, only after reasonable notice and opportunity for hearing under Chapter 68, Wisconsin Statutes, except as provided in 90-37 of this ordinance. Water service to such property shall not be restored until the unprotected cross connection has been eliminated.

Sec. 90-37. - EMERGENCY DISCONTINUANCE. The customer shall have an opportunity for hearing under Chapter 68, Wisconsin Statutes, within 10 days of such emergency discontinuance. Water service to such property shall not be restored until the unprotected cross connection has been eliminated.

ARTICLE II. - CROSS CONNECTIONS

CURRENT CODE

Sec. 90-31. - Definitions.

The following words, terms and phrases, when used in this article, shall have the meanings ascribed to them in this section, except where the context clearly indicates a different meaning:

Cross connection means any physical connection or arrangement between two otherwise separate systems, one of which contains potable water from the city water system, and the other containing water from a private source, water of unknown or questionable safety, or steam, gases or chemicals, whereby there may be a flow from one system to the other, the direction of flow depending on the pressure differential between the two systems.

SPS means safety and professional services.

NR means department of natural resources.

(Code 1972, § 13.13(1); Ord. No. 552, 6-13-2017)

Cross reference— Definitions generally, § 1-2.

Sec. 90-32. - Limited.

No person shall establish or permit to be established, or maintain or permit to be maintained, any cross connection. No interconnection shall be established whereby potable water from a private, auxiliary or emergency water supply, other than the regular public water supply of the city, may enter the supply or distribution system of the city unless such private, auxiliary or emergency water supply and the method of connection and use of such supply shall have been approved by the light and water department and by the state department of natural resources in accordance with Wis. Admin. Code § chs. NR 810 and SPS 382.

(Code 1972, § 13.13(2); Ord. No. 552, 6-13-2017)

Sec. 90-33. - Inspections authorized.

The light and water department shall cause inspections to be made of all properties served by the public water system where cross connections with the public water system is deemed possible. The frequency of inspections and reinspections based on potential health hazards involved shall be as established by the light and water department or by the council and as approved by the state department of natural resources. Any unprotected cross connections identified by the inspection shall be promptly corrected. Failure to promptly correct an unprotected cross connection shall be sufficient cause for the utility to discontinue water service to the property as provided under section 90-35 of this article.

Sec. 90-34. - Inspectors' right of entry.

Upon presentation of credentials, the representative of the light and water department shall have the right to request entry at any reasonable time to examine any property served by a connection to the public water system of the city for cross connections. Refusing entry to such utility representative shall be sufficient cause for the water utility to discontinue water service to the property. If entry is refused, such representative may obtain a special inspection warrant under Wis. Stats. § 66.122. On request, the owner, lessee or occupant of any property so served shall furnish to the inspection agency any pertinent information regarding the piping systems on such property.

(Code 1972, § 13.13(4); Ord. No. 552, 6-13-2017)

Sec. 90-35. - Discontinuance of service authorized.

- (a) The light and water department is authorized and directed to discontinue water service to any property wherein any connection in violation of this article exists and to take such other precautionary measures deemed necessary to eliminate any danger of contamination of the public water system. Water service shall be discontinued only after reasonable notice and opportunity for hearing under Wis. Stats. ch. 68, except as provided in this section. Water service to such property shall not be restored until the cross connection has been eliminated in compliance with the provisions of this article.
- (b) If it is determined by the light and water department that a cross connection or an emergency endangers public health, safety or welfare and requires immediate action, and a written finding to that effect is filed with the clerk and delivered to the customer's premises, service may be immediately discontinued. The customer shall have an opportunity for hearing under Wis. Stats. ch. 68 within ten days of such emergency discontinuance.

ORDINANCE NO. 589

TO PROVIDE A PROGRAM FOR PROTECTING THE PUBLIC WATER SYSTEM FROM CONTAMINATION DUE TO BACKFLOW OF CONTAMINANTS THROUGH THE WATER SERVICE CONNECTION INTO THE PUBLIC WATER SYSTEM

WHEREAS, Chapters NR 810, **NR 811 (added)**, and SPS 382, Wisconsin Administrative Code, require protection for the public water system from contamination due to backflow of contaminants through the water service connection; and

WHEREAS, the Wisconsin Department of Natural Resources requires the development and implementation of a comprehensive cross connection control program to effectively prevent the contamination of potable water systems;

NOW THEREFORE, BE IT ORDAINED by the Council of the City of Eagle River, State of Wisconsin:

Sec. 90-31. - DEFINITION OF CROSS CONNECTION. A cross connection is defined as any physical connection or arrangement between two otherwise separate systems, one of which contains potable water from the City of Eagle River's public water system, and the other of which contains water from a private source, water of unknown or questionable safety, or steam, gases, or chemicals, whereby there may be a flow from one system to the other, with the direction of flow depending on the pressure differential between the two systems.

SPS means Safety and Professional Services.

NR means Department of Natural Resources.

Sec. 90-32. - UNPROTECTED CROSS CONNECTIONS PROHIBITED. No person, firm, or corporation may establish or maintain, or permit to be established or maintained, any unprotected cross connection. Cross connections shall be protected as required in ch. SPS 382, Wisconsin Administrative Code.

[Removed NR 810]

Sec. 90-33. - INSPECTION. The water utility may inspect, or arrange for an inspection of, property served by the public water system for cross connections. The frequency of inspections shall be established by the water utility in accordance with Wisconsin Administrative Code. Any unprotected cross connections identified by the inspection shall be promptly corrected. Failure to promptly correct an unprotected cross connection shall be sufficient cause for the water utility to discontinue water service to the property, as provided under 90-36 of this ordinance.

Sec. 90-34. - RIGHT OF ENTRY. Upon presentation of credentials, a representative of the water utility shall have the right to request entry, at any reasonable time, to a property served by a connection to the public water system for the purpose of inspecting the property for cross connections. Refusing entry to such utility representative shall be sufficient cause for the water utility to discontinue water service to the property, as provided under 90-36 of this ordinance. If entry is refused, a special inspection warrant under **Section 66.0119 (changed from 66.122)** of the Wisconsin Statutes, may be obtained.

Sec. 90-35. - PROVISION OF REQUESTED INFORMATION. The water utility may request an owner, lessee, or occupant of property served by a connection to the public water system to furnish the water utility with pertinent information regarding the piping systems on the property. Refusing to provide requested information shall be sufficient cause for the water utility to discontinue water service to the property, as provided under 90-36 of this ordinance.

Sec. 90-36. DISCONTINUATION OF WATER FOR VIOLATION. The water utility may discontinue water service to any property wherein any unprotected connection in violation of this ordinance exists, and take other precautionary measures deemed necessary to eliminate any danger of contamination of the public water system. Water service may be discontinued, however, only after reasonable notice and opportunity for hearing under Chapter 68, Wisconsin Statutes, except as provided in 90-37 of this ordinance. Water service to such property shall not be restored until the unprotected cross connection has been eliminated.

Sec. 90-37. EMERGENCY DISCONTINUANCE. If it is determined by the water utility that an unprotected cross connection or emergency endangers public health, safety, or welfare, and requires immediate action, and if a written finding to that effect is filed with the City Clerk and delivered to the customer's premises, water service may be immediately discontinued. The customer shall have an opportunity for hearing under Chapter 68, Wisconsin Statutes, within 10 days of such emergency discontinuance. Water service to such property shall not be restored until the unprotected cross connection has been eliminated.

Sec. 90-38. - State plumbing code adopted. The city adopts by reference the state plumbing code, Wis. Admin. Code chs. SPS 381 to SPS 387.

Introduction

The Eagle River Farmers Market has become a vital community hub, providing a space for local farmers, artisans, and food vendors to engage with residents and visitors alike. To continue supporting the growth and success of the market, we propose an expansion project aimed at enhancing the infrastructure and facilities available at the site. This project seeks to improve the market's functionality, increase vendor capacity, and ensure a safe and welcoming environment for all participants.

Project Overview

The proposed expansion includes the following key elements:

1. Electrical Service Installation:

- **Primary Electrical Panel:** Install a new electrical service with a main panel to be located on the backside of the current market sign. This panel will serve as the central hub for the expanded electrical infrastructure.

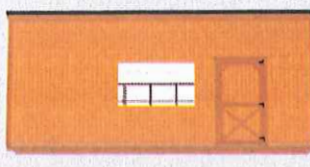

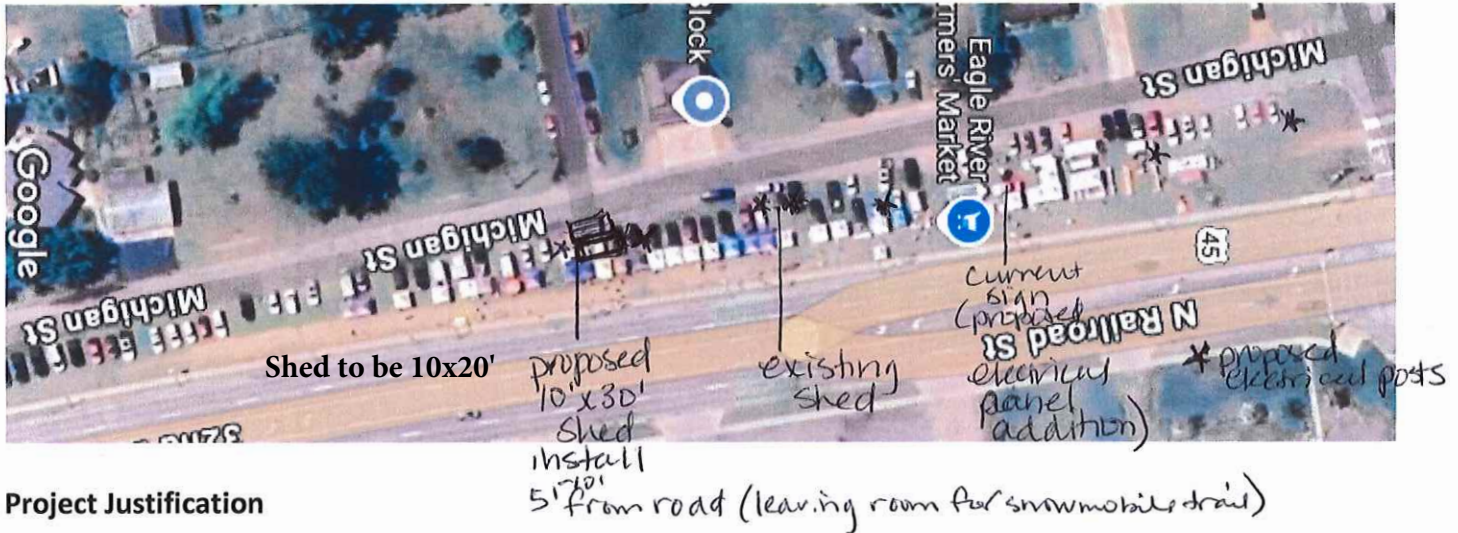

A Proposal to Revitalize the City of Eagle River

Eagle River Impact Grant

Objective:

The Eagle River Impact Grant aims to stimulate economic growth by transforming blighted, underutilized, or vacant spaces into vibrant commercial, manufacturing, or mixed-use spaces. This program seeks to incentivize investment in the City of Eagle River or areas to be annexed by offering financial support to business owners and investors who commit to revitalizing properties, creating jobs, and enhancing the local economy.

Key Details:

- Grant Amounts: \$10,000 to \$50,000 per project, with the possibility of exceeding \$50,000 for projects deemed significant by the grant committee and the Eagle River Revitalization Program (ERRP) Board.
- Total Available Funding: \$250,000.
- Match Requirement: All grants require a 50/50 match from the applicant, ensuring shared investment in the project's success.
- Target Applicants: Investors, business owners, and developers committed to transforming idle or underutilized spaces into commercial, mixed-use (including retail, workforce housing), manufacturing, or distribution centers.
- Eligible Spaces: Vacant land, underutilized or blighted buildings, and areas in need of rehabilitation.
- Uses of Funds:
 - Infrastructure improvements
 - Building rehabilitation or expansion
 - New construction for commercial, manufacturing, or distribution uses

 - Extensive Façade improvements and exterior renovations
 - Development of manufacturing or distribution centers to increase local employment opportunities.

Program Goals:

1. Economic Revitalization: Convert underutilized spaces into commercial, manufacturing, or mixed-use spaces, driving local commerce and job creation.
2. Job Creation: Support the development of manufacturing or distribution centers that provide significant employment opportunities within the community.
3. Urban Infill: Encourage investment in underutilized properties, filling vacant or blighted spaces to promote urban growth.
4. Collaborative Investment: Provide matching funds to leverage private investment for impactful community projects.
5. Integrated Support: Synchronize with existing programs to offer comprehensive support for business improvements in Eagle River.

Grant Structure:

- Tiers: Grants will be offered in tiers based on project scope and impact:
 - Tier 1: Small projects (e.g., façade improvements, minor rehabilitation) - up to \$10,000.
 - Tier 2: Medium projects (e.g., partial building renovations, small infrastructure updates) - \$10,000 to \$30,000.

- Tier 3: Large projects (e.g., full building rehabilitation, new construction, manufacturing or distribution centers) - \$30,000 to \$50,000.

- Sustainability: Projects that demonstrate long-term economic sustainability.
- Community Support: Proposals with community backing and matching funds will receive higher consideration.
- Investment Match: A 50/50 match is required for all grants.

Integrated Support with Existing Programs:

This new Eagle River Impact Grant will work in sync with the current:

- Sign Grant: Offers up to \$500 in matching funds for signage improvements.
- Building Improvement Grant: Provides up to \$2,000 in matching funds for building renovations, funded by the Eagle River Business Improvement District (BID).

Expected Outcomes:

- Transform at least 5 underutilized properties into productive, tax-generating spaces.
- Create 5-10 new businesses and/or manufacturing/distribution centers.
- Generate 50-100 new jobs in Eagle River.

- Timeline: Applicants will submit detailed proposals, including project plans, budgets, and timelines, with disbursement of funds required within the first 18 months of the project.

Report to the Eagle River City Council – End of September 2024

Submitted by Anthony Sable, PGA Professional/General Manager

Dear Council Members,

September 2024 revenue was up from last year. As the season finally slows down, it appears we had another good year - a record breaker. The recent nice weather has helped, and the course is in great condition. It appears our pricing strategy, attention to course conditions, and first-rate customer service has paid off again, with what appears to be another record-breaking year.

September 1 – September 30

*All Figures are After Refunds

ROUNDS

We had 3,001 rounds of all types in this period, up from 2,814 rounds in 2023. Green fee revenue was only \$75,963, down a bit from September 2023 at \$76,728.

CARTS

Carts of all types generated \$33,932 in September, strongly up from \$26,557 in September of 2023. Carts are all operable, in good condition and performed well this season. Maintenance and repairs were low this season, and not out of line with expectations.

RANGE

The practice range generated \$4,053, up a bit from last year's September total of \$3,683.

MERCHANDISE

Pro-shop merchandise sales were down from last year at \$11,632 in September, vs September 2023's figure of \$13,364.

TOTAL SEPTEMBER REVENUE

Total golf operations revenue for September was \$126,381, well up compared to September of 2023 at \$121,250.

YEAR TO DATE REVENUE

2024 total revenue to date comes in at **\$955,632**. This is up nicely from 2023's total of \$919,354. The superintendent will close the course for the season on October 14th. We might make another \$10 or \$12k in October, which will make 2024 very profitable but just short of our goal of 1 million in total revenue. A modest price increase next year, assuming relatively the same number of rounds, should bring us to that desired figure. Just for reference, in 2020, my first year here, we were doing just \$695,636. And even that was the best the course had ever done.

CONCLUSION

Labor was again a challenge this year, and we had to offer decent hourly wages to attract and keep good workers. The course was in fantastic shape this season and that made everyone happy and my job easier. Thanks to Kyle Anderson, our superintendent, and to his hardworking crew.

Thanks also to my assistant, Matt, and the rest of my wonderful staff, both inside and outside. So much of the credit for this course being in good financial shape goes to their daily hard work and dedication to our guest satisfaction.

Hi Robin,

As I did my final walk through of the site in prep for completing the roof, I happened to notice the fascia of the building was deteriorating, with the wood rotting in several places. The best way to protect the wooden fascia is to wrap it with aluminum to permanently protect it going forward. We would need to replace a few pieces of wood and then would wrap the wood with aluminum fascia in a green color to match the trim.

The additional cost to do this would be \$7,035.

Please advise if this is something you would like to move forward with. The fascia is the first item installed on the roof so we would need to order the product as soon as possible.

Section 105 Health Reimbursement Arrangement

Employee Instruction Sheet

City of Eagle River is continuing a Section 105 Health Reimbursement Arrangement (HRA) to help provide better health care coverage to employees and their families. HRAs are implemented by many employers to help manage increasing health care costs and to provide employees with an incentive to be better consumers of health care. They are working with Diversified Benefit Services, Inc. (DBS) to manage and administer the HRA. The program works as follows:

- You and/or your family members utilize your health plan as you normally would. When you use your health plan, the insurance company will process your claim and send an Explanation of Benefits form (EOB) to you. The EOB form shows the date of service, service provided, cost of the service, amount insurance paid on the claim.
- An Explanation of Benefits form (EOB) will *also* be sent electronically from the insurance company to DBS stating the amount of services applied toward the deductibles.
- As DBS receives the electronic information, the deductible amounts will be paid directly to the vendor/provider based on your employer's HRA reimbursement plan parameters.
- Prescription drugs are applied towards your deductible. You are required to pay for the prescription at the time of purchase. The HRA will reimburse you directly for prescription drug expenses based on your employer's HRA reimbursement plan parameters.
- If you provide your email address to DBS, all notifications including claims received, reimbursements issued and requests for additional information will be sent to you via email.
- There are no claim forms to file for the HRA. (However, if you have dual health coverage, you must submit EOB forms from the secondary insurance carrier manually along with a signed claim form for reimbursement.)
- The Health Insurance Plan is HSA (Health Savings Account) qualified and prescription drugs apply toward the deductible. Employees may set up a HSA with this Health Reimbursement Arrangement.

The HRA reimbursement is based on the Employer's in-network Group Health Plan. If you incur out-of-network deductible expenses then the reimbursement is capped at the in-network reimbursement level.



Additional Information:

- Employees are eligible for the HRA when they are eligible for and covered under the employers' group health plan. Employees not covered under the employers' group health plan are not eligible for the HRA.
- **At the end of each Plan Year there will be a 90-day run-out period** in which your claims with dates of service within the plan year will be electronically submitted.
- Any portion of the expense reimbursed by the HRA **IS NOT** eligible for reimbursement under any other program or by any other source. This includes, but is not limited to, Insurance Plans and Flexible Spending Accounts. Any portion of an expense reimbursed by the HRA **IS NOT** eligible as a deduction on your income taxes.
- If another source reimburses you and/or a provider (i.e. doctor, hospital, and clinic) for an expense that the HRA also reimburses you for, you are responsible for paying back the HRA Plan.
- Reimbursements are tax-free on your behalf.
- You have the right to waive participation in the HRA program for you and your family. You must waive participation each Plan Year and the waiver must be completed prior to the Plan Year beginning. Please see your Human Resource department for a waiver form.
- Your employer assumes the cost for the Plan's administration.
- This Employee Instruction Sheet is intended only as an overview of the HRA benefits. The HRA plan qualifications and limitations are stated in the Summary Plan Description. The Summary Plan Description determines how the HRA plan benefits will be administered.

All hazards plans are done at the county level but incorporate all local units within the county in the spirit of intergovernmental cooperation and to avoid duplication of the same work by each municipality. Local governments must have an approved local all hazards mitigation plan to remain eligible for certain FEMA disaster funds that would be available after a disaster declaration. Additionally, FEMA may require a local unit to develop and adopt an all hazards plan following a disaster in that community. Adoption of this county all hazard plan satisfies the planning requirement, so that the City does not have to go through the time and expense of creating a plan from scratch. Updates are required by FEMA every 5-years.

Please consider the attached sample resolution or one similar to it, at an upcoming City Council meeting. Let me know if you would like a copy of the MS Word file for ease of use. Forward a signed copy of the approved resolution to my office, and I will file it with FEMA to satisfy the requirement for your community. If you have any questions or comments regarding the Plan, please forward them to my attention. Also note: should the community ever need an amendment to the Plan in the future, please contact me.

City Administrator's Report

September 2024

Admin/General

We've had some growing pains between the new group therapy center on 5th Street and a couple of neighbors. The therapy center will be putting a fence around the back yard in October, which will hopefully contain their clients and therapy dogs. I've spoken to both the center director and the neighbor. I gave the director some local resources to help get the kids outdoors and let her know that the dogs – although well trained therapy dogs – still need to be on leashes. I then shared updates with the concerned neighbor, confirmed with her that they are a state licensed facility, and let her know what to do if there are kids in her yard, or if she sees the therapy dogs out of the yard without a leash. Hopefully, things will settle down as they get settled in their new home and get the fence up around the backyard.

I forwarded a letter to the Council, written by a local resident, regarding the abundance of deer in Eagle River. Attached is that letter. With the mild winter last year, the urban deer population seems to have exploded. Is this an item the Council wants to act on or pursue?

We're still hard at work trying to balance our 2025 budget so we can start moving in the right direction. Adam from Baird will be on-site one more time to help us on a few things before we schedule the budget workshop next month. I believe the only number we're still waiting on is the liability/business insurance premiums. Health insurance is coming in at a resounding 0% increase for 2025, which is fantastic!

Departments/Committees/Commissions

Golf Course – I took my season-end tour with Kyle to look at the condition of the course, talk about how things went this year and what projects were completed, then to begin the conversation about projects for 2025. I've said it earlier this summer, but the grounds are stunning! The fairways look like carpet, tee boxes continue to be improved, the flower boxes are lovely... the list goes on. I've received absolutely zero complaints about our golf course and facilities, run by Kyle and Tony, this season. In fact, quite the opposite – we've received glowing compliments on the course and management.

The restaurant has been a little up and down, but that's for a separate conversation. I suspended a season pass holder for the remainder of the season over a physical altercation with the bartender over politics. *sigh* Overall our golfers are behaving better since implementing the code of conduct. I usually have to issue one or two warnings a season, but otherwise they're taking the rules seriously.

Police Department – The PD union contract only accounted for one year of wages; therefore, we have a wage reopener to discuss at the October meeting. I have the Union's recommendation, and we'll talk about this in closed session.

Public Works –

See attached for DPW report on September activities.

River Trail Commission – GHT facilitated a planning session aimed at determining the future and feasibility of the River Trail project. They contracted with a consultant who has experience building bike-ped trails around the state. She will develop a report for GHT, and the information will be disseminated to the Commission and municipalities. The next River Trail Commission meeting is scheduled for October 30.

Zoning/Planning – Beginning October 2nd there's a major Frontier fiber-optic installation project happening in Eagle River. L&W and DPW met with Frontier to manage the diggers hotline requests to stay ahead of their work. They are aiming to be done by the November 10th right-of-way deadline for excavation in the City. If they are not done, we may need to visit this as a Council at the November meeting for an extension, based on weather.

The demolition of the building at 106 E Wall Street has begun. They had a dumpster out front for one day while they removed the interior demo debris. They will be tackling the exterior demolition the week of October 7th. The sidewalk will be closed and a dumpster will be on Wall Street. That phase should take no longer than one week.

2024 Projects

Dog Park/Elm Drive Parcel Sale – The two lots on Elm Drive have been officially listed, and we have an offer for over listing price for Lot #3. This will be reviewed at the Council meeting.

According to our listing agent, we've gotten a lot of good traffic online looking at the two lots, and several calls in for info as well. She is confident the other lot will sell fairly quickly, which will open us up to build the dog park right away in spring.

I've received one pledge for sponsorship and am working on a second one. This will help with things like dog poo bags, repairs/maintenance, water service bills for a water spigot. I think this will be very well received and used when we get it built.

Maple/Birch Street Resurfacing – The first lift of blacktop was laid ahead of Cranberry Fest, and Pitlik knows we can't really have anything blocked off for the weekend of the festival. The entire project will be complete by the end of October.

Silver Lake Eurasian Water Milfoil Monitoring – We are working on a grant through Onterra to cover the post-treatment monitoring expenses for 2025. We were not successful on the treatment grant application, but my understanding from Onterra is the monitoring grants are a little less competitive. There will be a resolution in the packet for approval to apply for the funding.

Dear Administrator Ginner;

I'm pretty sure you've noticed the explosion in the urban deer herd in recent years, and having had essentially no winter in '23-24, it has gotten much worse. In 2020-21, we routinely saw around 10-13 animals in a single yard. In Feb 2024, I counted 20 in the school playground across from City Hall, just outside your office window, and there were plenty of twins dropped this spring. If they stayed on the playground, this would not be a problem, but they tend to move around, and they like to eat.

The tendency of deer to walk around puts them in city streets constantly. If a car approaches the posted city speed limit, it risks a deer encounter, and reflexively swerving can put that car into the path of cars, bikes, or pedestrians, a hazard magnified by winter snow and ice. I live near the blind curve that forms 6th St, and multiple times I've had to hit the church parking lot either to avoid deer, or avoid a car that's trying to do the same. Luckily, no cars have yet been in that part of the parking lot at those times.

The deer are eating everything that can't outrun them. I stopped putting up bird feeders years ago because I don't want to draw deer right up to my house. My back yard was thoughtfully planted years back (by my mom) with native pollinators that are traditionally "unpalatable" to deer. (These plants all co-evolved with deer, so they survive and thrive in a normal ecosystem.) Yes, I'm well-aware no plant is "deer-proof," but there are better and worse choices, and as the population boom puts pressure on desirable food, they're eating things they wouldn't normally touch, including toxic plants such as tansy and columbine. Over the last 7 years I've gone from a meadow full of lupine, aster, daylily, columbine, bergamot, milkweed, goldenrod, and soapwort to a scrub of ryegrass and woodfern. The few struggling survivors grow almost to bloom before getting scalped. This year I lost all my black cohosh (a favourite of wild bees, and a previously-untouched plant), which was growing within 6 feet of my door. The milkweed used to host monarch caterpillars; the last few years I've watched the cats grow until ready to pupate, only to find the entire plant eaten by deer the next day. Haven't seen a single monarch egg or caterpillar this year. Since I see roadsides just outside of the city limits (i.e. where hunters and predators exist) that are full of these various species, it doesn't seem like too much to ask that homeowners be allowed to have them as well, without having to put up unsightly and cost-prohibitive 8-foot perimeter fences to protect species that *deer don't like*.

Since what goes in tends to come out, our property has become a minefield of deer feces that I have to track down before I mow, and my dogs can't hang out in the yard due to their doglike tendency to eat or roll in the waste. This obviously further limits our enjoyment and use of our own property.

Lastly, the urban "feed 'n' breed pen" is a primary or secondary vector to myriad parasites and viruses that cause harmful, chronic, and sometimes fatal conditions to humans and pets, including Lyme, anaplasmosis, erlichiosis, mange, and a banquet of other costly vector-borne diseases that are increasing as the winters get

warmer and tick populations increase. And a herd that is so overcrowded spreads CWD. This might not seem a big deal if you're not eating venison, but a suffering, starving deer is not a good look to the tourists or anyone else, and the disposal of carcasses we've found on our property is a hassle to say the very least.

The sentiment shared with every neighbour I've spoken to is that the city needs to develop and execute a robust control plan immediately. Not "shoot a buck in Trees and call it a year," but a real, visible, and meaningful reduction in numbers across sexes and ages. 12 seems like a good start; 20 seems like a good goal. My neighbour is a bowhunter, and I live on Silver Lake. I would be delighted to have him, or anyone else, plug away in my back yard. (Heck, I could hunt with a hoe, if I wanted to field-dress in my driveway.) There is no reason the city has to be a lawn-grass monoculture, divorced from the greater northwoods ecosystem we've historically enjoyed.

Clerks Report September/October 2024

Elections: Absentee ballots began going out September 17 and we continue to get applications to mail out daily. Military and Overseas ballots have been emailed. Absentee vote in person begins on October 22 and goes through November 1. New registrations are coming in daily. Voting at the care facilities is scheduled for October 14 and the ballot packs/registrations/absentee applications have all been compiled for the deputies. The tabulator battery has been charged, ink and paper supplies checked, the RAVE emergency system tested. The poll workers schedule has been completed for November. I produced training sessions for the poll workers doing election day registrations. I will be training my SVD election workers on October 9 and will do a pre-election training for all General Election poll workers on October 21. Most of my month has been election related.

Operators Licenses: Not too many this month again.

Permits/Licenses:

We received an application from Kenneth Body for launching a public fireworks display at the Eagle River Airport again for 2025. The launch proposed launch area has moved to the area inside the fence off Bolte Road and this move has been approved by the Airport Commission.

We have an application for Christ Lutheran Church for December 6-7 for their Live Nativity. They will have a donkey, a horse, and sheep for the live reenactment.

World Championship Derby Complex LLC has submitted their 2025 snowmobile event applications, information has been distributed to all those affected including NPSD with regards to road closures.

All events are compiled/updated into a document that is shared with all department heads, ERRP, the Chamber and the fire department for planning.

Insurance: The Golf Course claim with our property insurance has been paid less the \$1000 deductible. I have submitted a request for restitution with the DA in this case. 2025 insurance renewals are starting, and the Auto and Workers Compensation schedules have been completed and returned to our agent for our 2025 quote. Security Health Insurance is presenting a no increase quote for 2025.

DOT Lease Agreement: We received the DOT five-year lease agreement renewal for the property behind the Depot without any renewal changes, remaining at \$150 a year. The agreement has been signed and returned.

Lease Agreements: Invoice was sent to Petreikis for the land lease between Trackside and snowmobile trail and reminders sent to the Historical Society for the Depot lease.

Open Records Request: I processed two open records requests.

Special Assessment Requests: I have processed three special assessment requests since the previous council meeting.

Department of Revenue Form Filing: There were no form filings required this past month, but I continue to pull DOR 2025 Aid estimates as they come available for budgeting.

Meetings: Following the September meetings, all licenses and permits were produced, mailed/emailed to the applicants. The Planning Commission, Finance Committee, and City Council meeting draft minutes were produced and a truncated version of the City Council meeting minutes, with all motions, was published in the VCNR. Resolutions were executed and saved digitally and filed in the physical resolution book. All Clerk items were added to the October City Council agenda. All Clerk supporting documents for the October City Council meeting were prepared and supplied for Robins meeting binder. All Eagle River agendas were posted onto the bulletin boards, sent to the email distribution list, and posted onto the website. All Vilas County, ERRP, NPSD, Airport, and LVG supplied agendas were posted on our bulletin board.

Budget: Updates to the 2025 budget draft continue as estimates and requests continue to come in.

Ambulance: Met with community leaders and EMS officials to gain knowledge of the current ambulance system. The Joint Ambulance Commission will be meeting in October to discuss the ambulance service in Joint Commission area.

Taxes/Assessor: The final assessment roll has been received with all changes during the open book and BOR periods. The roll is balanced with Vilas County and the County has our affidavit to file the PA-521 Statement of Assessment with the DOR.

I am still waiting on legal descriptions for the airport hangars from the Surveyor. With Tom Boetcher retiring from Eagle Landmark Surveying, Greg Maines has agreed to do our annual boundaries legal description so I can file that with the DOA at the end of each year.

Quarterly room tax notices were sent out Sept 30 with a due date of Oct 31. I have been actively gathering information on the permitting process and looking at some updates to that process.

Garbage:

The 2025 recycling grant application has been forwarded back to Vilas County Planning and Zoning by their deadline.

Reminder: The first yard waste pickup is scheduled for October 16, the second pick up on November 6.

The holiday garbage pickup schedule was confirmed with Republic Services including the scheduling of the Christmas tree pickup on January 15. Garbage pickup will remain on the regular schedule for Thanksgiving, move to Friday the week of Christmas, and remain on the regular schedule for New Years.

Clerk Certification/Training: I continue with clerk/election training, adding another focus on the Treasurer side. I attended the MTAW Fall Treasurers Conference this month and a couple of MTAW District meetings, all had great educational value.

City Hall: Toiletry orders for the city, golf course, and parks are finally slowing down.

AMENDMENT #1
TO JOINT INTERGOVERNMENTAL COOPERATION AGREEMENT
BETWEEN THE TOWNS OF ST. GERMAIN, CLOVERLAND AND
THE CITY OF EAGLE RIVER DATED JULY 11, 2018

WHEREAS, the above matter has come before the River Trail Commission because of a need to amend the original Joint Intergovernmental Cooperation Agreement between the municipalities; and

WHEREAS, the City of Eagle River wishes to amend the document to allow a non-elected official to act as its representative on the River Trail Commission; and

WHEREAS, the remaining members of the Commission and the Towns of Cloverland and St. Germain have no objection to this modification;

NOW, THEREFORE, in consideration of the promises contained herein; IT IS HEREBY AGREED that the Joint Intergovernmental Cooperation Agreement between the Towns of St. Germain, Cloverland and the City of Eagle River is hereby amended as follows:

1. Section 1.A. is amended to read as follows:

"A. When the Commission is composed of an odd number of municipal governmental bodies, each one shall appoint one Town Board member or the City Council of the City of Eagle River may appoint a non-elected member as its primary voting member of the Commission. When the Commission is composed of an even number of municipal governmental bodies, each one shall appoint one Town Board member or Council member, or the City of Eagle River may appoint a non-elected member as its primary voting member of the Commission, except for Cloverland which will appoint two Town Board officials. (Six miles of the 10-mile trail will be located in Cloverland.)."

2. That this constitutes the entire change to the original Agreement and no other amendments to the original Agreement shall be permitted unless reduced to writing and signed by all municipalities and their representatives. That any part of the original Agreement not modified herein shall remain in full force and effect.
