Signatures required for all Withdrawals or Disbursements from Local Treasury

Resolution # 1056

2027 Salary increase for the Council members and Mayor

Whereas, the City of Eagle River Common Council met in regular session for the Organizational Meeting on April 15, 2025, and

Whereas, upon the agenda was the discussion of salary increase for the Council members and Mayor, and

Whereas, upon much discussion, in order to maintain compensation commensurate with their responsibilities and duties, as well as, comparability to similar sized communities in the area;

Now, therefore, it is resolved:

- I. That the Mayor's salary is hereby increased to the amount of \$23,400 per year with the position to remain a part-time position with hours to be provided as needed.
- II. That the Council members shall have their salary increased to the amount of \$6,900 per year.
- III. The Council President shall have his/her salary increased to the amount of \$8,100 per year.
- IV. That the salary increases for both the Mayor and the Council shall become effective at the first meeting of the new Council following the April 2027 election.
