JUNE 2025 CITY COUNCIL MEETING REPORT

- > All Bank Statements are reconciled up to May 2025 statements.
- > Accounts payable check sent out weekly.
- > Daily printing and distributing vendor invoices to departments for approval of payment.
- CLA noticed that the account number used in Workhorse for WRS, Health Insurance, etc for the golf course was incorrect and that will also be corrected. This was set up by Workhorse at the beginning of the program use.
- It was suggested by Scott Sternhagen of CLA that we combine the golf course with the city GL accounts to eliminate the due to and due from accounts. We would still have the golf course account numbers in the city GL so that we can keep track of the profit and loss, etc. This will be discussed in detail when Scott comes to the city council meeting with the audit.
- > Payroll and reports processed every other week.
- City Council and Mayor payroll done monthly.
- Monthly Sales and PRAT Tax reports to the WI Dept of Revenue for golf course sales. This is done monthly even if there are no revenues.
- > 2nd QTR 2025 Payroll Reports done before end of month after last payroll
- Weekly bank deposits for regular business
- > Worked on monthly credit card statement, separating invoices and charging to correct accounts.
- > Daily posting of point of sales for the golf course into the Workhorse accounting system.
- Processed background checks for the licensing through the clerks office. They still need to be approved by the police chief.
- > Helped with the 4 new employees, set all 4 up in Workhorse and sent out all necessary paperwork for them.
- > Processed monthly reports for city council meeting
- Entered 2024 CLA Journal Entries into Workhorse when received on June 5th.
- Received email from Tony Sable of 2 invoices not paid for from Sun Mountain. I had not received them. Contacted Sun Mountain and established that they were sending to the incorrect email address. Corrected that issue.
- > Called Trig's Food and Postal for a copy of an invoice that was on statement.
- Wisconsin Building Supply please make sure to get the invoices to me when you charge there. I have had numerous instances of invoices needing to be emailed to me.
- Check sent to MTAW for Becky's membership was sent to incorrect mailing address. Reversed check in Workhorse and resent to correct address. Incorrect check was sent back and marked VOID.
- > Invoiced out AFLAC and Security Health Plan to Golf Course, Light and Water and Airport. This is done monthly.
- Reconciled due from accounts. I do this on a quarterly basis.
- > Invoiced Turkey's Clubhouse and Eagle River Revitalization for monthly expenses paid by city.
- Processed request for a credit card for the new police officer and new DPW Supervisor on June 17th.
- Processed new golf course employees in Workhorse and removed inactive employees from the active file box to inactive file box.
- > Made new golf course pro shop timesheet spreadsheet
- Recorded uniform expenses for DPW employees
- ▶ Invoiced Light and Water, Golf Course, and Airport for 2nd QTR 2025 LWMMI and W/C insurance.

- Wrote apology letter to employees on June 20th about payroll fiasco and sent out to them as per text message from Mayor Deb Brown.

- Received phone call from Zones concerning past due invoices. Found out they were sending them to the incorrect email address. Corrected that and received them for payment.

- > Entered bank "sweeps" into accounts as of June 25th.
- Entered new life insurance amounts in Workhorse to start on next check. Also noticed that the amount that was being deducted from their checks was incorrect, so corrected that as of January 1st thru June 20th checks. The difference will be charged to their upcoming July 3rd paycheck.
- > Filed Video Service Provider Report for state on June 27th.
- > Worked with Becky and learned how to do the first part of the Room Tax. Sent out the quarterly reminders.

I want to apologize from the bottom of my heart in regards to the payroll fiasco on Friday, June 20, 2025.

I take full responsibility for all the mishaps that occurred.

Some have asked what happened, so here is the timeline:

- On Wednesday, June 18th, 2025, I was not feeling well at all. I did come to work, thinking it was the green pollen affecting my allergies and asthma. Nope, that was not it.
- I processed the payroll in the morning of the 18th and tried to send the ACH files to Incredible Bank so that the payroll would be in there for Friday. I was having issues with the Incredible Bank website, so I called them and was informed that they were having issues with it at that time.
- Again, I was feeling terrible, so I emailed the files to myself at home so that I could try from home. I then went home sick.
- When I got home, I did try to post the ACH files for the payroll, but the website was still down, so I laid down for a nap and left a note for my husband to wake me up in the evening. Well, he didn't, so I did not wake up until Thursday morning.
- When I did wake up on Thursday, I immediately went to the computer and was able to send the files to the bank. But, in my haste, I scheduled them to be sent out on Friday, June 27th, NOT June 20th. They did not have an option for June 20th on the site.
- Yes, I totally forgot it was a federal holiday.
- When Robin called me Friday at 8:05 am, I immediately called Incredible Bank and talked to my contact, Heidi Reiter-Kramsvogel. She started the process to correct the issue, informing me at that time that it may take until the end of the day to get this processed.
- Heidi called me back a few minutes later and stated that it may be around 11 am before the checks can be released. I was very happy with that.
- Heidi then called me back about an hour later, letting me know that now it may not be until 4 pm before they are released.
- I did keep Robin in the loop with the updates I received.
- When 4 pm came and went and still no paycheck, I called Heidi but was unable to talk to her.
- I kept checking my bank account to see if the paycheck cleared, and it was not until 8pm that I did notice the ACH in my accounts being processed. It was not until 9pm that the payroll checks were in my accounts.

Again, I am truly sorry for the delay in the payroll. I promise this will not happen again.

June 10, 2025

A meeting of the Common Council of the City of Eagle River was called to order at 6:00PM by Mayor Deb Brown.

The Pledge of Allegiance was led by Becky Bolte and was recited by all present.

Roll Call: Dan Dumas, Kim Schaffer, Vic Washelesky and Jerry Burkett. Also in attendance: Robin Ginner, Becky Bolte, Cory Hoffmann, Chris Dobbs, Adam Ross, Mike Adamovich, Brad Adamovich, Mike Sanborn, Tony Sable, and Kyle Anderson.

Motion by Burkett, 2nd by Schaffer to approve the agenda in any order. Carried, all.

Motion by Dumas, 2nd by Burkett to approve the minutes of the 5/13/25 Finance Committee and Common Council meeting. Carried, all.

a) <u>Protect and Serve Award Presentation –ERPD Patrol Officer, Dustin Wichmann</u>: Assistant Police Chief Adam Ross presented Green Bay Packer Protect and Serve award stating Dustin Wichmann, who was not available to attend this meeting, had received this award based on his 2024 record. Wichmann was second in most traffic stops and tied for most OWI arrests in the county last year. He also retrieved a suspect and his drugs from the Eagle River after suspect jumped off of the bridge last summer. The Packers awarded him with a plaque and the award comes with a \$2,000 grant for the police department.

b) Ordinance #595 - Amending Chapter 74 – Solid Waste, Article II – Collection & Disposal, Division 2 – License, Sec 74-64 License Fee: Removing set licensing fee and adding fee to be set by Council Resolution. Motion by Schaffer, 2nd by Washelesky to adopt Ordinance 595, Amending Chapter 74 – Solid Waste, Article II – Collection & Disposal, Division 2 – License, Sec 74-64 License Fee: Removing set licensing fee and adding fee to be set by Council Resolution. Carried on a roll call vote, all. c) <u>MSA Monthly Updates</u>: Phil Kriesel of MSA provided a written report including updates to the Silver Lake Road project, and information on MSA moving from their current GIS program to ESRI's Experience Builder program and the city's plan to move ahead with this conversion.

i. Change order for Silver Lake Road Project to add storm sewer and street rising on McFaul Lane for \$37,980, plus additional engineering up to \$4,000: Ginner explained this change order is to address a standing water problem off McFaul Lane and the need to protect electrical transformers at that location. Funding will be provided for in approved 2025 Capital Improvement funding package. Burkett confirmed this is not Burkett owned property. *Motion by Schaffer, 2nd by Dumas to approve change order for Silver Lake Road Project to add storm sewer and street rising on McFaul Lane for \$37,980, plus additional engineering up to \$4,000. Carried on a roll call vote, all.*

ii. MSA 2025 Safe Streets 4 All grant re-application contract, \$2,000: Ginner presented that the city was not successful in 2024 with this grant but was optimistic with new changes for 2025. The grant has potential for 90% funding coverage/10% match grants. *Motion by Burkett, 2nd by Schaffer to approve MSA 2025 Safe Streets 4 All grant re-application contract, \$2,000. Carried on a roll call vote, all.*

d) <u>Eagle River Light & Water: Resolution #1059 – 2024 Compliance Maintenance Annual Report</u>: The 2024 DNR Compliance Maintenance Annual Report was presented and reviewed by Council. The report shows a total Grade Point Average of 4.00 with total points being awarded in all sections. *Motion by Schaffer, 2nd by Dumas to adopt resolution 1059 – 2024 Compliance Maintenance Annual Report. Carried on a roll call vote, all.*

e) Golf Course:

Golf Pro Tony Sable provided a written report including a marketing report. Sable reported the season is going well so far but rain has been a factor. The possibility of extending cart life with windshield replacement on all golf carts was presented. Sable to supply Council with an estimate for windshield replacement on the 66 golf carts. Sable reported the Golf Association is recognizing the Ladies Golf League as having the most members in the league in the State of Wisconsin.

Grounds Superintendent Kyle Anderson reported that the flowers have been planted and there is a new flower bed and statute erected on Hole 13 from the ladies' league dedicated to Lou Gremban. 80 tons of sand will be added to the course bunkers. The Greens Department crew will be putting down gravel on the cart paths from the 1st green to the 2nd t-box and from the 2nd green to the 3rd t-box.

f) <u>Request for change of date for pre-approved fireworks permit from July 4 to July 5, 2025</u>: Kenny Body presented that in working in conjunction with Land O'Lakes – fireworks on the 3rd, and Phelps – fireworks on the 4th, he would like to change the Eagle River fireworks date as to not compete with neighboring displays. Bolte confirmed Airport Manager Rob Hom and Police Chief Dobbs were ok with the change. Fire Chief Michael Anderson spoke against the fireworks for safety and liability. Anderson provided documentation, summarizing court cases involving municipalities and fireworks liability, showing cases where there was a lack of liability coverage for fireworks claims. The City of Eagle River is insured through League of WI Municipalities. Anderson confirmed there would be three fire fighters on call for July 5. *Motion by Burkett, 2nd by Dumas to approve Kenny Body requested change of date for 4th of July fireworks, location off Bolte Road, from Friday July 4, 2025 to Saturday July 5, 2025 upon compliance with all previously required stipulations as motioned with the applications original approval at the 10-8-2024 City Council meeting. Carried on a roll call vote. Ayes: Burkett, Dumas, Washelesky Nays: Schaffer*

The City of Eagle River was awarded a \$320,971.32 MSID grant from WISDOT for the reconstruction of Silver Lake Road from the intersection of Sheridan Street and Silver Lake Road to the City limits near the swimming beach. Our estimate at the time of the bid was \$670,244. The planned project is to include replacement of the pavement and provisions for a sidewalk on the south side of the project.

Added to the Silver Lake Rd Project will be drainage corrections near the end of Mc Faul Lane. This area regularly sees flooding or standing water. Electrical transformers and standing water don't mix. To correct the situation storm sewer inlets and piping will be installed to the east connecting to the existing storm sewer system. ORDINANCE NO. 597

AN ORDINANCE CREATING SECTION 86-220 OF THE MUNICIPAL CODE OF THE CITY OF EAGLE RIVER TO AUTHORIZE THE TOWING OF ILLEGALLY PARKED VEHICLES

The Common Council of the City of Eagle River, Vilas County, Wisconsin, does hereby ordain as follows:

SECTION 1. Creation of Section 86-220.

Section 86-212 of Chapter 86, Division 4 of the Municipal Code of the City of Eagle River is hereby created to read:

Sec. 86-220. – Towing of Illegally Parked Vehicles.

(a) The Chief of Police, Mayor, or City Administrator is hereby authorized to order the towing of any motor vehicle found to be illegally parked on any public street, alley, or city-owned parking lot within the City of Eagle River.

(b) For the purposes of this section, an illegally parked vehicle includes, but is not limited to, vehicles:

- Parked in violation of posted regulations;
- Obstructing driveways, alleys, crosswalks, fire hydrants, or intersections;
- Parked in a manner that impedes snow removal, emergency response, or general public safety;
- Abandoned or left unattended in a location where parking is prohibited.

(c) The cost of towing and storage shall be the responsibility of the registered owner of the vehicle.

(d) The City may contract with private towing services for the removal and storage of vehicles under this section.

SECTION 2. Effective Date.

This ordinance shall take effect upon passage and publication as required by law.

<u>Admin/General</u>

I have done my best to prepare for my extended absence. To reiterate, I will be out on medical leave for rotator cuff surgery beginning June 30, and I anticipate being out for six weeks, returning mid-August. I've provided a list to Becky of things to anticipate in my absence, and have cross trained her on issuing zoning permits so a backlog doesn't occur. Most are pretty easy, but she plans to call me if anything unusual comes up. My plan is to be completely unavailable for the first two weeks (I understand this is the worst of it...) then I will be working remotely as I am able until my return in August. Thank you for your patience during this time. If something critical comes up, please feel free to call me on my cell phone.

IT Issues and Potential City Response (IMPORTANT)

This is an especially important issue that's reared its head on several fronts recently and will require City action in the coming months.

I had a scheduled meeting with our contact at Norvado on June 26, 2025, to review the proposed service updates set to take effect on January 1, 2026. Unfortunately, she did not attend the meeting, and I have since left two messages without receiving a response.

As we know, Norvado will no longer support our current phone system beginning January 1, 2026. If we choose to continue with them, the City will need to purchase a new phone system. Once I see what phone system they are proposing I can look at the state purchasing program for better pricing. Additionally, they are proposing upgrades to our internet infrastructure, but I have yet to receive any details on what those upgrades entail or what the associated costs will be.

We do know that the cost of police department cameras around the city is expected to increase significantly—from approximately \$30/month per camera under ChoiceTel to around \$100/month under Norvado. Without a full breakdown of proposed services and costs, it's difficult to assess the financial impact on the City.

Compounding the situation, Chris Dobbs has informed me that the Sheriff's Department will no longer provide IT support to the police department after June 2026. This also includes cameras. I have contacted Paladin, as recommended by the PD, to talk about replacing the cameras at the golf course but haven't received as estimate from them yet.

We recently had significant delays in IT support from Silver Bay as the owner and sole proprietor underwent hip surgery and was slow to respond to any requests. This included getting Becky's new computer set up as she continued to struggle with her old malfunctioning laptop for longer than expected

All of this points to a much broader conversation that needs to happen. Chris has agreed to begin that discussion at the July meeting. The City needs to prepare for a major IT initiative, sooner rather than later. Key items for consideration include:

- A citywide VOIP (voice of Internet) phone system
- Internet access upgrades for all City buildings and departments
- Security camera systems upgrades and support across all departments

- An evaluation of the City Hall server and its capabilities
- The potential need for a new IT support provider—ideally a company with the capacity and expertise to manage the City's full range of IT needs, including cybersecurity. Our current support model is essentially a one-person operation, and I have serious concerns about adequacy given the increasing complexity and risks in today's digital environment.

This is a critical infrastructure issue, and we'll need to approach it with a comprehensive and strategic plan.

Departments/Committees/Commissions

<u>Golf Course</u> – The approved electrical bid has been returned to the contractor. He's aiming to fit the work in between other projects, likely sometime in July. I'll provide a schedule update as soon as I hear back from him.

Naturally, just as temperatures started rising, the air conditioning unit at the golf course failed. It's approximately 25 years old and now needs full replacement. With forecasted highs near 90°F, the Mayor authorized the purchase of a few portable AC units to temporarily cool the clubhouse. DPW has installed them, and while they are helping, they are not a substitute for central air conditioning.

I received a quote from Culver's for a new AC unit and a replacement for our small furnace, which is also about 25 years old. The total cost is \$20,000 to replace both units (and includes removing the balance of the existing system from the attic, which accounts for some of the expense). However, Mark Culver strongly recommends adding attic insulation in addition to replacing the HVAC system. During summer months, attic temperatures can reach 120–150°F, significantly reducing the efficiency of the AC unit. The system is not only fighting the outside heat but also extreme heat radiating downward.

The AC/furnace replacement quote is included in the packet for approval.

Based on Mark's recommendation, I've also met with three insulation contractors for attic insulation quotes. One declined the job due to the difficulty involved, but I expect quotes from the other two before the upcoming meeting.

Additionally, I received a call from one of our league players (who asked to remain anonymous) informing me that the men's league is currently boycotting the restaurant and bar due to dissatisfaction with the current offerings. Some women's league members have also chosen to take their business elsewhere. This may be worth considering when we revisit the restaurant lease later this fall.

As a kudos to Kyle and his Greens staff, when I met with Mark Culver, he mentioned the golf course looks to best he's ever seen it in his 62 years in Eagle River. I recommend the Council members ask Kyle for a tour if you haven't had the opportunity to look at the Course.

Public Works -

From all reports, our new employees are doing great! I've checked in with them all since beginning work for the City, just to see how things are going, and they've reported back on how helpful the entire existing crew has been in getting them up to speed. Good news!

Brad requested a new computer for the office. The old desktop that's in there is ancient and is both running extremely old programs and also keeps giving him notifications that it can't be updated. They do have a limited life. So, I've included a price for a new desktop from BestBuy (approx. \$700) in the packet. Because it does not have a connection to our server, we don't need it to go through Silver Bay (at the extra cost for a firewall). We will make sure it has the appropriate anti-virus software. We can do a budget amendment from another DPW budget line item to cover the cost of the new computer.

DPW report on June activities attached to this report (Appendix A)

<u>**River Trail Commission**</u> – ERRP, GHT and I have been working with the DOT on the crossing at Riverview Park. As you may remember, Karen Margelofsky was successful in receiving the Vibrant Spaces grant to construct a better pedestrian crossing for the area, and I understand she has also received a generous donation to help with the project. The DOT has asked that the design be slightly modified and has also requested additional pedestrian counts if possible, so she is working with GHT to provide that information back to them.

<u>Zoning</u> – After two written requests—one last fall and another in May—the ongoing garbage/rubbish issue at the SW corner of 3rd and Maple has only begun to be resolved. After two notices to the property owner, and an ordinance violation ticket from the police, the property owner claims 2,000 pounds of rubbish has been removed. That said, there is still a bunch of junk back there, so they asked for a little more time because they were doing it during the recent heat wave. My concern is they're going to continue to use the weather as an excuse to prolong the clean-up.

Pastor Rob Dixon from Abundant Life Church reached out to me to ask whether he could request reconsideration from the Council regarding the sewer connection requirement tied to the conditional use permit for the house they purchased to use as a youth annex. He's basing his request on what Geos paid, but it appears the \$40,000 figure he received likely included more than just the sewer tap.

Kim Schaffer said she's willing to sponsor the item for the agenda, but only if Rob provides a cost estimate for the sewer connection beforehand. I've communicated this requirement to him. At this point, I'm not sure if he'll have the estimate in time for the July meeting, or if it will need to wait until August. It's tentatively on the July agenda, pending receipt of the requested estimate. Because the church is in Jerry's ward, but he recused himself from the original discussion, Kim has agreed to sponsor the agenda item

The current permit condition requires the connection to be completed by Labor Day. Mike, Moe/Brad, and Deb have been copied on the email chain so they're aware of the ask.

2025 Projects

<u>**Property Sales**</u> – The Bond Street parcel is schedule for closing on July 11 at Gowey Title. We did have to provide them with a \$400 deposit for the services, which will be refunded once the transaction is complete.

I'm still waiting for Aspirus to get back to me regarding the property easements on the corner of Indiana and Hospital. I have followed up a few times, and the most recent update from attorney I've been working with is that he will be taking it to the powers that be for input.

Hopefully by the time I return to the office we'll have that taken care of so we can move forward with the sale.

<u>Silver Lake Road</u> – After several months of work, I believe we've gotten to the end of the process on securing the required easements on the Cook property ahead of the August construction start of Silver Lake Road resurfacing. They did request one final amendment to the document, but after discussing it with Steve Garbowicz, he felt it was a moot point as the request fell within the existing road right-of-way. I've responded to the Trustees and am awaiting final endorsement. They confirmed their willingness to sign the document with that one amendment, so I'm hoping after the explanation they will follow through with signature without the requested language.

McFaul Lane – MSA requested that I get approval from both Burkett and Walgreens to perform the storm sewer connection from the transformers at the end of McFaul Lane to the existing storm water inlet on the Walgreens property. A storm water easement already exists for the Walgreens property, so I sent notice to their store manager alerting her of the project in August. I have requested permission in writing from Burkett to cross his property to access the inlet. We can move forward with written permission for now, but we should seek a permanent easement in case any further work or maintenance needs to be done to the storm sewer line in the future.

<u>Clerk's Report</u> June/July 2025

<u>Elections</u>: Wisconsin Elections Commission mailed out 2025 Four-Year Record Maintenance notices in June. Any elector that has an active status, registered on or before December 31, 2021, and has not voted since December 31, 2021, receives a notice of suspension of voter registration. The electors then have an opportunity to confirm their City of Eagle River residence and desire to remain registered. I work through each notice and deactivate/reactivate as required. This process keeps our registered voters poll list up to date.

<u>Liquor/Tobacco License Renewal Applications:</u> All Liquor licensing and Tobacco licensing renewals have been distributed to the applicants. The DOR form AT-827 has been submitted with all license information. Records have been finalized and filed for retention. Overall, the renewal year was busy but went pretty smooth.

<u>Operators Licenses</u>: Operators licenses expire on June 30 annually. This month we have a few that missed the June meeting deadline so provisional 60-day licenses were issued to carry them over until the July 8 Council review/approval.

<u>Events:</u> We've got a flea market coming to town. Bob Zurko has submitted a direct sellers/promoter application for August 30 & 31 at the Vilas County Fairgrounds. Along with application scans being shared with City Department heads, a list of ALL events/park reservations is updated monthly and shared with the ER Police Dept, Light and Water, DPW, Chamber Director, ERRP Director, and Fire Chief to keep all in the know.

<u>Open Records</u>: I've had many open records requests this month. I have had communication with the Attorney to ensure proper compliance. For preservation and ease of information, I scanned and converted 30 years of minutes into a searchable format.

<u>Special Assessment Requests</u>: I have processed four special assessment requests since the previous council meeting.

<u>Meetings:</u> Following the June meetings, all licenses and permits were produced, mailed/emailed to the applicants. The Finance Committee, City Council, and Special City Council meeting draft minutes were produced and a truncated version of the City Council meeting minutes, with all motions, was published in the VCNR. All Clerk items were added to the July City Council agenda with supporting documents and meeting packets were created and distributed. All Eagle River agendas were posted onto the bulletin boards, sent to the email distribution list, and posted onto the website. All Vilas County, ERRP, NPSD, Airport, and LVG supplied agendas were posted on our bulletin board. The digitized minute book has been updated to current for both the City Council and Planning Commission.

<u>Dept of Revenue Filings:</u> Maintenance of Effort DOR Form SL-305 has been submitted to the DOR, due by July 1 annually. The report includes documentation that the municipality maintained a level of fire protective and emergency medical service that is at least equivalent to that provided in the previous year. The Eagle River Fire Department and Aspirus were timely in supplying me with the information needed to file.

Garbage: The lease document for Gary's Garbage & Recycling has been fully executed.

<u>City Hall:</u> With the weather finally warming up, swim lesson registrations have picked up. Many families have registered for multiple/all sessions. The garage door at the PD had a broken cable and J&Z came and repaired it. The keypad back door to City Hall was repaired by Entrance Technologies.

<u>Trainings:</u> Cory and I will be attending the Clerk/Treasurers Institute the week of July 14 – 18. This is my final year with the Clerks/Treasurers Institute. Mayor Brown will open up the Clerks office and work from the main room during her regular office hours that week, but the office will be closed outside of Mayor Browns hours. As a member of the Institutes Advisory Board, I am once again mentoring first year students through UW-Green Bay. I hosted an orientation on June 25 for registrants in WMCA District 8.
