a) MSA Monthly Updates: Phil Kriesel of MSA provided a written update including updates to the Silver Lake Road project. Drainage corrections near the end of McFaul Lane were added to the Silver Lake Road project, adding sewer inlets and piping to the East connecting to the existing storm sewer system to prevent standing water at the existing electrical transformers. The Pre-construction meeting is scheduled for 7/24/25. A Temporary Construction Easement and Permanent easement between Jonathan C Cook Irrevocable Trust and the City of Eagle River Easements for the Silver Lake Road project were presented.

Motion by Washelesky, 2^{nd} by Schaffer to approve temp construction easement between Jonathan C Cook Irrevocable Trust and the City of Eagle River. Carried on a roll call vote, all.

b) <u>Eagle River Light & Water:</u> ERLW Manager Mike Sanborn presented an update on the water tower reconditioning project that began on July 1, 2025. Sanborn presented an update on wastewater; Aqualis has provided ERLW with a list of recommended sanitary sewer pipe and manhole repairs. There appears to be some discrepancies with the manhole numbers that were on the list provided. The problems with the list will be rectified and brought back to Council for quote approval at the August City Council meeting. Sanborn

reported BIO solids, the sludge in wastewater, came back with a PFAS detection. Sanborn confirmed this was not found in our wells, and that a possible primary source is being investigated.

c) <u>Department of Public Works:</u> Mike Adamovich/Brad Adamovich presented problems of misuse of the Elm Drive stump dump stating they have video of residents hauling in full large trees, stressing the dump is for yard waste. Discussion on potential fines for illegal and/or contractor dumping. Brad Adamovich is following up with current violators, giving a one-time warning and explanation of the rules. Chief Dobbs added the current fine structure for illegal dumping was \$173.50. Town of Lincoln Chairman/Board to be contacted to open up a conversation on how best to enforce the rules of what is/isn't accepted at the site.

VRC requests a letter stating the following: The City of Eagle River will accept full responsibility to display the AH-1 helicopter that was displayed at the American Legion Post 114 at 418 W Pine St, the city would lease the helicopter to display at the VRC for \$1 per year, the VRC must maintain and display the helicopter as a proper military monument, the VRC would main insurance coverage on the helicopter. Matt Becker, League Insurance CEO, recommended that the following be incorporated into the lease: VRC is responsible for insuring the helicopter from a property standpoint, be responsible for any maintenance and snow removal, hold the city harmless from any damage or injuries, and carry liability insurance that names the city as an additional insured. Discussion on what happens when/if the VRC no longer wants helicopter display as it would need to be returned to the military, with Rusty Wolf stating the next entity on the list for a helicopter display would pay to get it to them. Burkett and Dumas stressed that the display is an honor and thanked those that served. Jerry Burkett offered to personally pay for the fees associated with lease creation by Attorney Garbowicz. SILVER LAKE ROAD (R00088117)

Construction began on August 11th. To help keep residents informed, the contractor has installed a message board at the Silver Lake Rd and Sheridan St. intersection.

The contractor will begin by pulverizing the existing roadway prior to starting additional work. The installation of storm sewer infrastructure will require the first full closure of Silver Lake Road. Once the road base is removed in this segment, road access will again be restricted.

Throughout the project, the road segment between Bond Street and Sheridan Street is expected to be closed to traffic at times. A detour route will be in place to quide drivers around the construction zone.

MSA will have a resident project representative on site, actively engaging with residents to provide updates and address concerns.

The City of Eagle River was awarded a \$320,971.32 MSID grant from WISDOT for the reconstruction of Silver Lake Road from the intersection of Sheridan Street and Silver Lake Road to the City limits near the swimming beach. Our estimate at the time of the bid was \$670,244. The planned project is to include replacement of the pavement and provisions for a sidewalk on the south side of the project.

Added to the Silver Lake Rd Project will be drainage corrections near the end of Mc Faul Lane. This area regularly sees flooding or standing water. Electrical transformers and standing water don't mix. To correct the situation storm sewer inlets and piping will be installed to the east connecting to the existing storm sewer system. The city plans to move forward with the upgrade to Experience Builder in 2025. The current GIS apps will continue to work until the upgrade is complete.

WDNR INTENT TO APPLY - CLEAN WATER FUND AND SAFE DRINKING WATER LOAN PROGRAMS

In October MSA again submitted ITA's for projects the City will consider over the next year. There is no fee for this service. It is important to think about what possible projects could come up in the next year to apply for. This should be looked at like a wish list. Funding changes will happen over the next year, and this is the required first step in using DNR loan and grant programs.

As you know I have called you to see if I could either purchase the lot next to mine on silver lake or if I could gain deeded access to the lot which I believed was solely owned by the City of Eagle River so that I would not have to build a walkway over the Marsh area on my lot to get to the lake. Prior to and since those conversations I contacted Lake Country Title to do some research for me.

What I have learned is that prior to the city of Eagle River getting an interest in the lot (8) (221-DI-30, a copy of map is attached) that the original grantors, Harry Pride, Virginia Pride and Everett Hoover and Doris Hoover deeded that lot to Blocks 2, 3, 4 & 5, (See Deed dated August 8th, 1955, a copy is attached). Which gave the owner of lot 4 an equal and undivided ownership in lot (8). An Interest in Lot 8 was deeded to the City of Eagle River pursuant to document 198787 and recorded on August 19th, 1980, (I have attached a copy for your review).

When the city sold lot #4 to me (221-880-01), the deed I received failed to have the language that should have been included recognizing my interest in lot #8. The first deed gives all of the owners in the Silver Lake Addition of Blocks 2, 3, 4 & 5 ownership in that lot. The second deed is where the City of Eagle River got my parcel. The second deed included the verbiage of equal and undivided ownership.

"Also, equal and undivided ownership in lot (8), Block 1 of the recorded plat of Silver Lake Addition to the City of Eagle River, Wisconsin, for their use as a bathing beach and boat landing".

The city did not include that language in my deed which I believe and the title company believes it should have. What I am asking the City to do is have a correction document drafted and filed recognizing and correcting my original deed as the language should have been there originally. I do not know if this need to be an agenda item or not.



Dear Deb:

I have had numerous discussions with Kim Schaffer and Al Moustakis about his request to have his deed which he received in 1999 modified to provide that he has docking and bathing rights to Silver Lake. In essence, it gives him the legal right to use the lengthy pier that crosses a wetland to access Silver Lake.

In the title policy that we purchased back when we sold the property to AI, for whatever reason, Northern Title at the time did not include the docking and bathing rights for his property in that title policy or on his deed. The principals involved with that research are no longer here with us and therefore, I can't find out the reasoning why it was not included. Legally I think an argument can be made that yes, it should have been included as well as an argument that could be made that no, it was not part of his land purchase and by the fact that he has not raised this issue for 26 years we shouldn't have to deal with it now.

I would suggest you put this on the next Council agenda for an up or down vote from the Council to give him these docking and bathing rights as permitted in a deed from 1955 and request that I then draft a Correction Instrument or a Scrivener's Affidavit to fix his legal description from 1999.

ORDINANCE NO. 598

AN ORDINANCE AMENDING SECTION 106-274 OF THE ZONING ORDINANCE OF THE CITY OF EAGLE RIVER REGARDING FENCING MATERIALS PROHIBITING ABOVE GROUND ELECTRICALLY CHARGED FENCING IN AND/OR ADJOINING RESIDENTIAL ZONING DISTRICTS

The Common Council of the City of Eagle River, Vilas County, Wisconsin, does hereby ordain as follows:

SECTION 1. Amendment.

Section 106-274 of the City of Eagle River Zoning Ordinance is hereby amended as follows:

1. **Subsection (1)** is amended to add the following sentence at the end:

Above ground electrically charged fences are prohibited in and/or adjoining all residential zoning districts.

2. **Subsection (5)** is amended by deleting the sentence:

Barbed wire fencing is not permitted when adjoining a residential property.

3. **Subsection (2)** is amended to add the following sentence at the end:

Barbed wire fencing is not permitted when adjoining a residential property.

SECTION 2. Effective Date.

This ordinance shall take effect upon passage and pub	lication as required by law.

Wisconsin Legislature: 2021 Wisconsin Act 197

66.0440 Battery-powered, alarmed electric security fences.

- (1) In this section:
- (a) "Battery-powered, alarmed electric security fence" means an electric fence that satisfies all of the following:
- 1. Is equipped with an energizer that produces direct current and is powered by a commercial storage battery with a voltage of not greater than 12 volts.
- **2.** Produces an electric charge on contact that satisfies standards provided by the International Electrotechnical Commission, as published in the latest version of the commission's standards for electric fence energizers.
- **3.** Is connected to a system that is capable of signaling law enforcement.
- **4.** Includes warning signage that a battery-powered, alarmed electric security fence is in operation.
- **5.** Is surrounded by a perimeter fence or wall that is at least 5 feet in height.
- **6.** Is no more than 10 feet in height, or 2 feet higher than the perimeter fence or wall, whichever is higher.
- **(b)** "Political subdivision" means a city, village, town, or county.
- (2) No political subdivision may do any of the following:
- (a) Prohibit the installation or use of a battery-powered, alarmed electric security fence, except on property designated exclusively for residential use.

(b) Require a permit, other than an alarm	n system permit, for the install	lation or use of a battery-po	wered, alarmed electric
security fence.			

- (c) Impose installation or operation requirements that are inconsistent with the standards set by the International Electrotechnical Commission for installation or operation of an electrified fence that is a component of a battery-powered, alarmed electric security fence.
- (3) No person may locate a battery-powered, alarmed electric security fence on property designated exclusively for residential use.

Clerk's Report July/August 2025

<u>Elections:</u> The 2025 Four-Year Record Maintenance deadline was July 15, and I was able to clean up our poll list with deactivations of registration for those that did not respond to the notice or came back undeliverable or with forwarding addresses. The second quarter Movers list was processed with 30-day letters mailed out. EDR cards for the April election were processed and reported through WisVote.

<u>Liquor/Tobacco License Renewal Applications:</u> I've been working with another Salon that is considering a liquor license to provide wine to their clientele, providing her with all the rules and regulations that go along with the license. I have had a few salon owners come in since Act 73 was passed allowing salons to obtain a license, but the rules and regulations of licensure seem to outweigh the want. Currently, I have not received the application.

Events: We have a couple events on the agenda for approval. Trees for Tomorrow Forest Fest is on an every other year schedule and the Three Eagle Half Marathon and 5K has been an annual event. Due to rain, the canoe races for the ER Historical Society have been rescheduled for August 20 at Riverview. The remaining dates for Eagle Days in August and September have been cancelled at the VC Fairgrounds. We also had the Woodland Strings at Riverview Park Band Shell on July 27 that was approved by the Mayor and Police Chief as the application came in after the last Council meeting. Along with application scans being shared with City Department heads, a list of ALL events/park reservations is updated monthly and shared with the ER Police Dept, Light and Water, DPW, Chamber Director, ERRP Director, and Fire Chief to keep all in the know.

<u>Special Assessment Requests</u>: I have processed three special assessment requests since the previous council meeting.

<u>Meetings:</u> Following the July meetings, all licenses and permits were produced, mailed/emailed to the applicants. The Finance Committee, City Council, and Special City Council meeting draft minutes were produced and a truncated version of the City Council meeting minutes, with all motions, was published in the VCNR. In Robins absence, all items were added to the August City Council agenda with supporting documents and meeting packets were created and distributed. All Eagle River agendas were posted onto the bulletin boards, sent to the email distribution list, and posted onto the website. All Vilas County, ERRP, NPSD, Airport, and LVG supplied agendas were posted on our bulletin board. The digitized minute book has been updated to current for both the City Council and Planning Commission.

<u>Dept of Revenue Filings:</u> The Department of Revenue contacted me on July 23 concerning the Expenditure Restraint Incentive Program form filing. This form is filed to qualify for annual shared revenue for municipalities that meet an expenditure percentage increase cap and averages about \$50,000 annually. The DOR believed the figures were misrepresented. With the changes to our debt following the TID refinance, I worked with Baird and CLA to complete this form for 2026 qualification, with both signing off before submittal. On July 28, I did a video conference with Baird, DOR and myself and we were able to satisfy the DOR concerns by amending two lines that did not affect the bottom-line qualification.

Closing on Sale of Bond Street river parcel #221-457: The week of closing on the parcel, the buyer presented concerns about an easement on the property. I worked with Garbowicz on a resolution and he was able to provide an affidavit of use to remove exception 15 from the commitment: "Privilege of Trespass as set forth in that document recorded March 7, 1923 in Volume 6 on Page 127, as Document No. 28839 and in that document recorded July 14, 1944 in Volume 12 on Page 522, as Document No. 64613". The closing was pushed back a week, but Mayor Brown closed on the sale on July 18.

<u>Lease Agreements:</u> I wrote the lease agreement with the Veterans Resource Center for the helicopter and Garbowicz gave me approval without any changes. The agreement was executed with the VRC, and the full application has been completed and returned for VRC submittal to the US Army Tank-Automotive and Armaments Command. There was a qualification line item prohibiting the display from being on privately owned land. We did not misrepresent or initial the line item stating it would only be on City owned land. The VRC is confident this will still go through.

<u>Insurance</u>: The Wisconsin League of WI Municipalities Insurance 2025-2026 Safety Grant totals \$1270. We rotate by departments for who receive these funds for safety equipment purchases. I was able to use \$419 towards the replacement of the pads and battery in the City Hall AED machine, and the remaining \$851 has been allocated to the Light and Water Department. We have a claim at the golf course submitted using the no fault medical coverage up to \$10,000. Statewide has opened the claim and they are verifying qualifications for coverage.

<u>Taxes:</u> I have received all but one second half tax payment for the airport hangar invoice process. I will give the mail a couple of weeks to get here and then send out a reminder for the outstanding \$289.37 if not received. The total collection with the outstanding single payment has been balanced and covers the city expenditure for 2024 of \$44,566. The 2025 tax year will be the new normal for hangar taxation and all hangar tax bills will be generated by Vilas County as a standard real estate bill.

Zoning: In Robins absence, I was tasked with filling in for her basic zoning duties. She gave me a crash course before she left, and I have issued an array of permits. We have a few new residential builds happening, a garage on Tamarack, a residential home/garage on Sherburn, an application for a home/garage on Bond that needs Council attention due to lot size, along with excavation permits, sewer taps, signs, and I've provided applications and information to a few looking to start with the building process. I was in touch with Robin to review before final permit issuances and with questions that I was unable to confidently answer. It's been good cross training.

<u>City Hall:</u> I am working on scheduling with Spencer Holmes of the ER Fire Department on scheduling CPR/AED training. The cost is \$55 per person, \$25 for those age 62 and up. I am working on getting a few of my regular election inspectors certified along with any interested office personnel.

<u>Trainings:</u> I have completed my fourth year of certification training from UW-Green Bay. This year was my Treasurers track training. UWGB also offers Alumni training, and I hope to be able to continue with them for educational opportunities in the future. Next month I have MTAW virtual training on advanced tax roll preparation and budgeting along with the Wisconsin Elections Commission conference in Rothschild.
