Moving Structure	\$100 + dept fees (plus a \$1,000 refundable deposit)
New Structure	\$.25/sq ft (not to exceed \$1,000)

Additions	\$.25/sq ft (not to exceed \$1,000)
Demolition	\$100

New Structure	\$.25/sq ft (not to exceed \$1,000)

INDUSTRIAL ZONING DESIGNATION	
Additions	\$200 + \$2/\$1,000 of building cost (not to exceed \$1,000)
Demolition	\$100
Hangars	\$200 + \$2/\$1,000 of building cost(not to exceed \$1,000)
Moving Structure	\$100 + fees (plus a \$1,000 refundable deposit)
New Structure	\$200 + \$2/\$1,000 of building cost(not to exceed \$1,000)
Signs	\$100
MISCELLANEOUS ZONING PERMIT FEES	
Adult Entertainment Business Permit	\$300 (conditional use)
Annexation	\$250
Communication Tower Permit	\$3,000
Conditional Use Permit/Public Hearing Request	\$300 (conditional use)
Excavation	\$50
Request to amend an ordinance	\$300
Re-Zoning	\$300
Sewer Tap Fee	\$350
Storage in excess of 30 days	\$75
Variance Application	\$300
Weed abatement/Lawn Mowing/Snow Removal	\$125 base fee plus \$50/hour, minimum one hour assessed on tax bill.
Zoning Board of Appeals Hearing Request	\$300

Permit fees are waived for projects that cost less than \$2,000.00, government related projects or projects deemed in the public interest.

(h) Revocation of Permit: If the holder of the permit fails to comply with the provisions of this chapter, or Chapter 14, of this Municipal Code, the City Zoning Administrator or the Zoning Board of Appeals may, upon written notice and opportunity to be heard, revoke the permit. Revocation by the City Zoning Administrator or Zoning Board of Appeals may, upon written notice and opportunity to be heard, revoke the permit.
